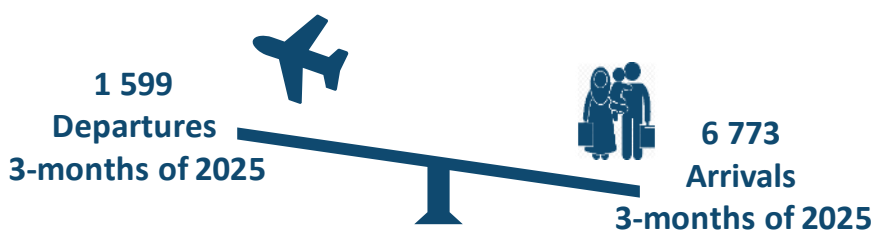

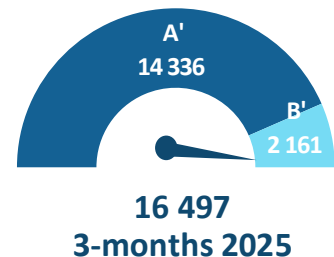

Arrivals increased by 1% in March 2025 compared to the corresponding month of 2024.

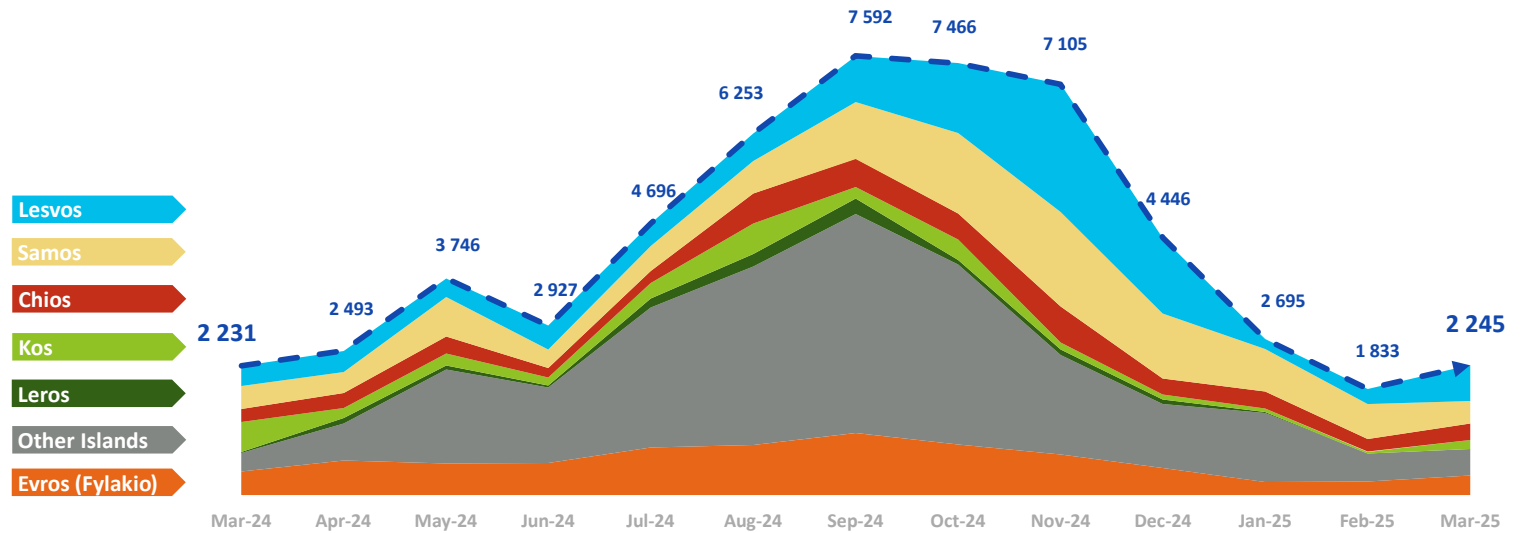


Chart 1. Migration flows (islands of Eastern Aegean sea and Evros March 2024 – March 2025 – See Appendix Table 1

Transfers in March 2025 decreased by 40% compared to the corresponding month of 2024.

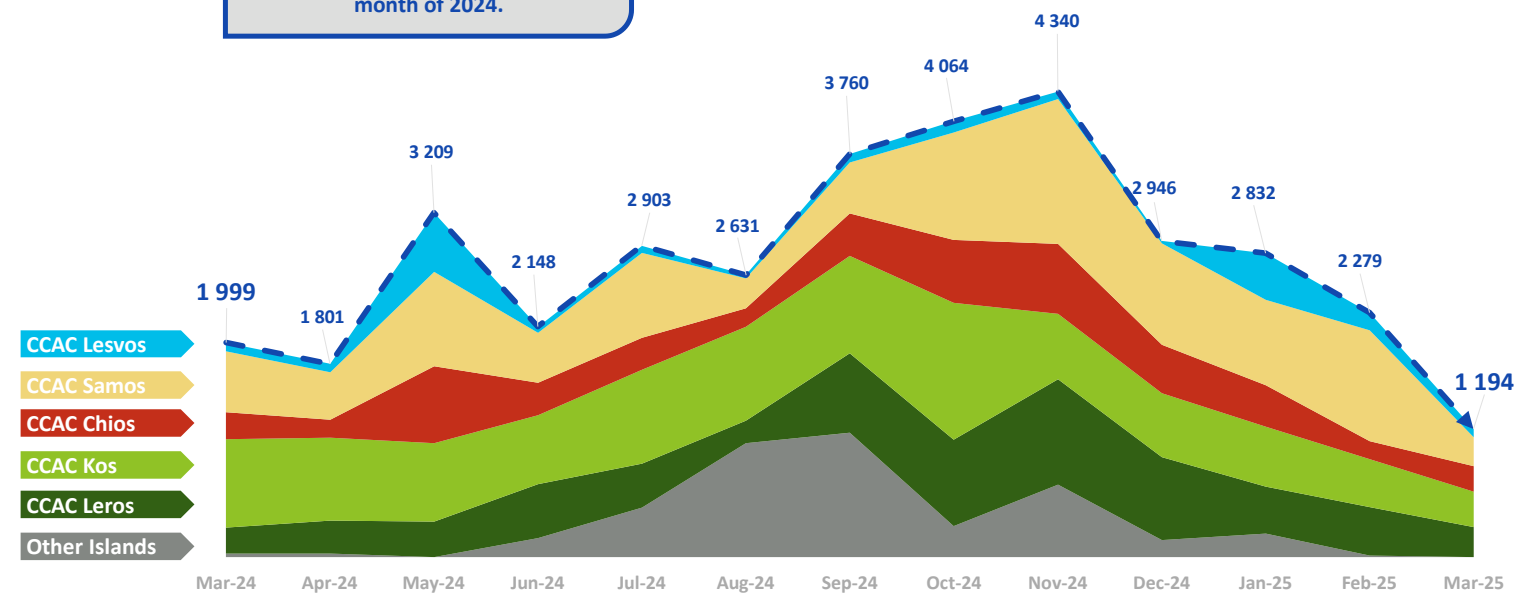


Chart 2. Transfers of asylum seekers from the islands to the mainland March 2024 – March 2025 - See Appendix Table 2

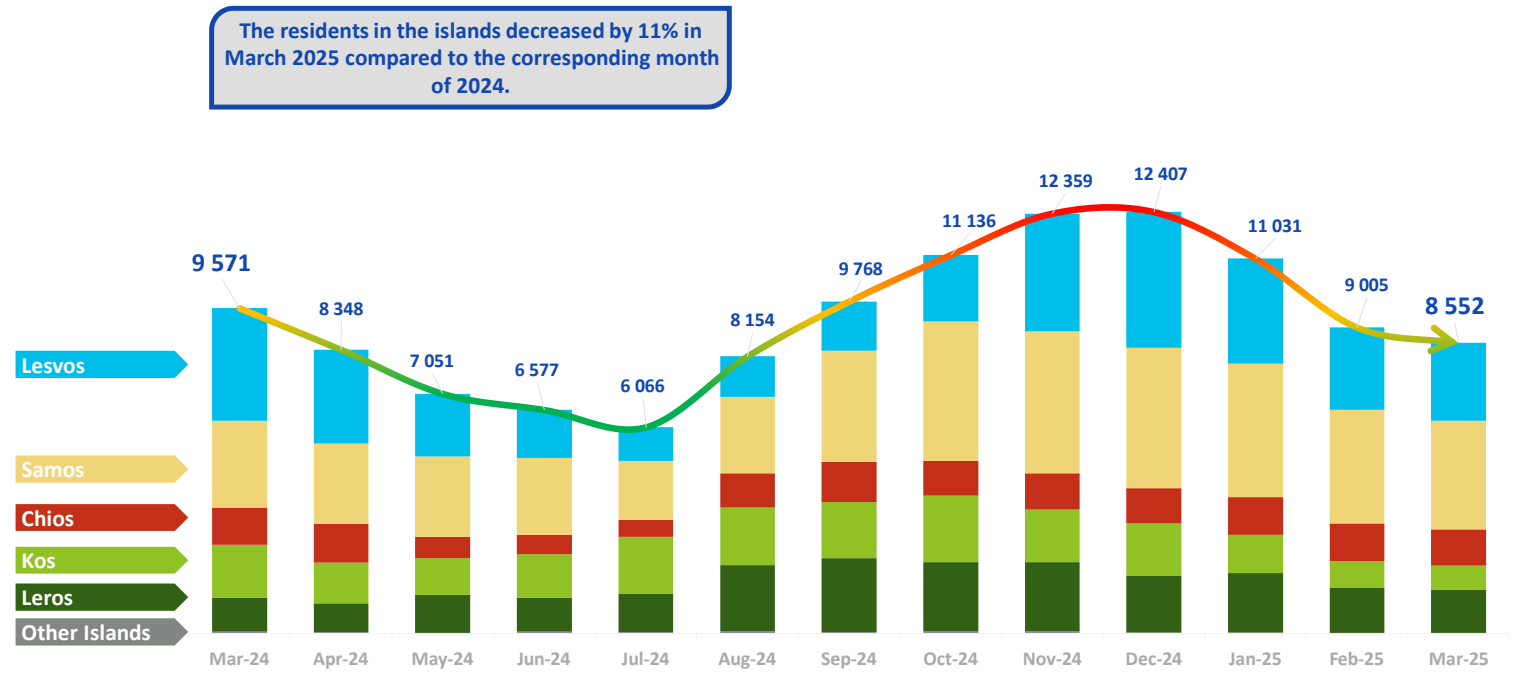


Chart 3. Island Residents in total March 2024 – March 2025 - See Appendix Table 3

4. Distribution of Asylum Seekers per Region and Accommodation scheme

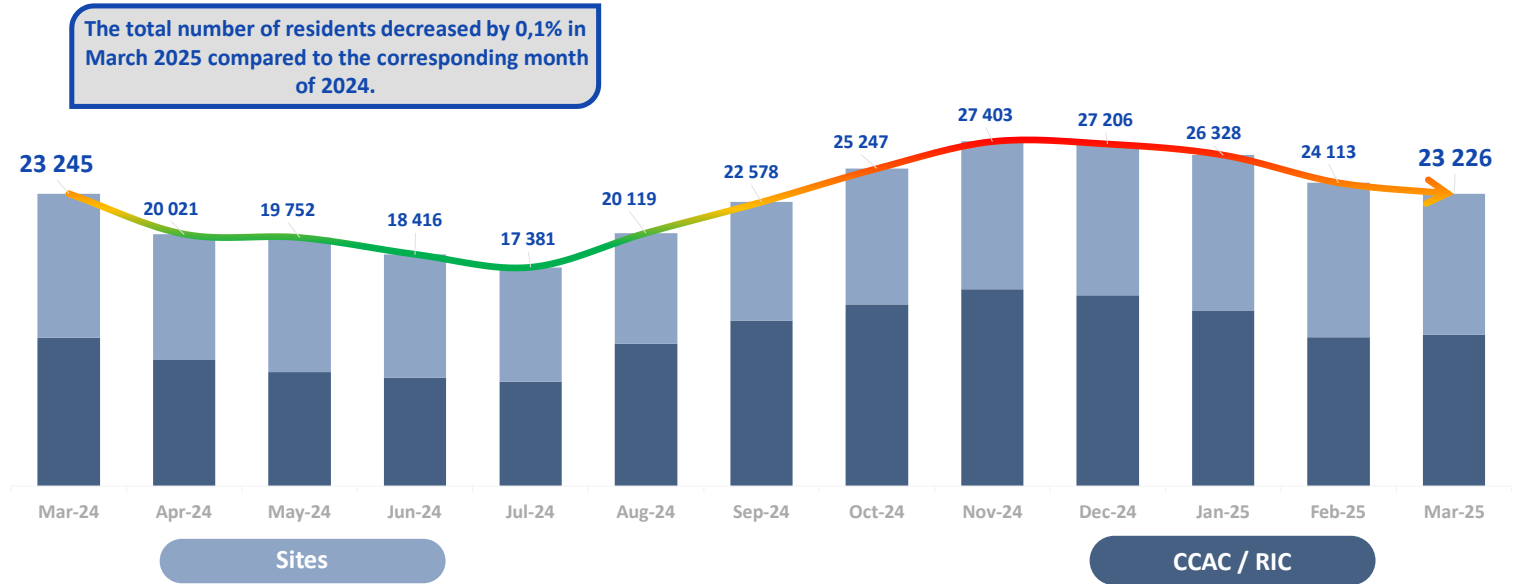

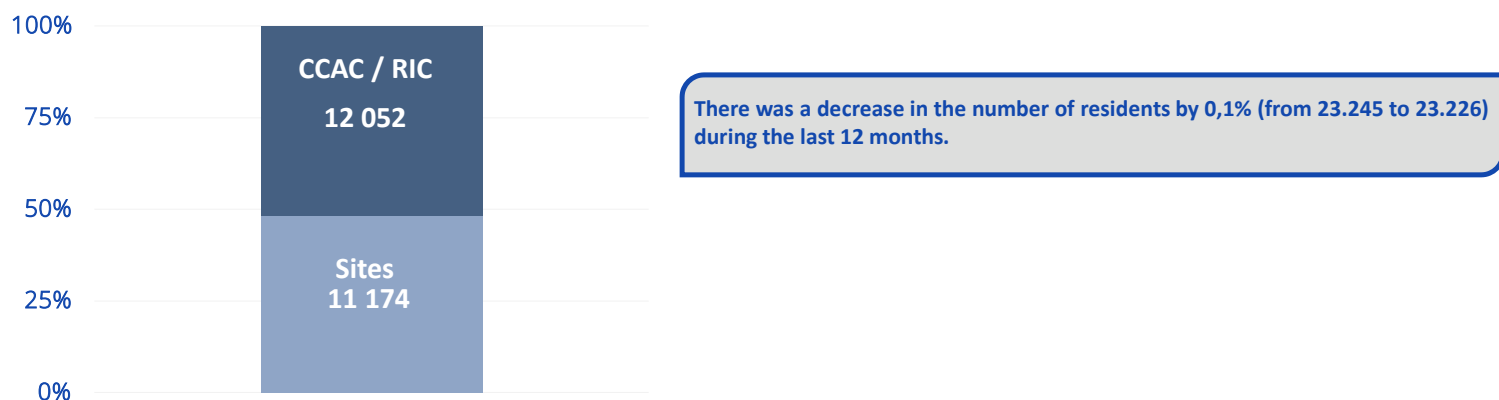
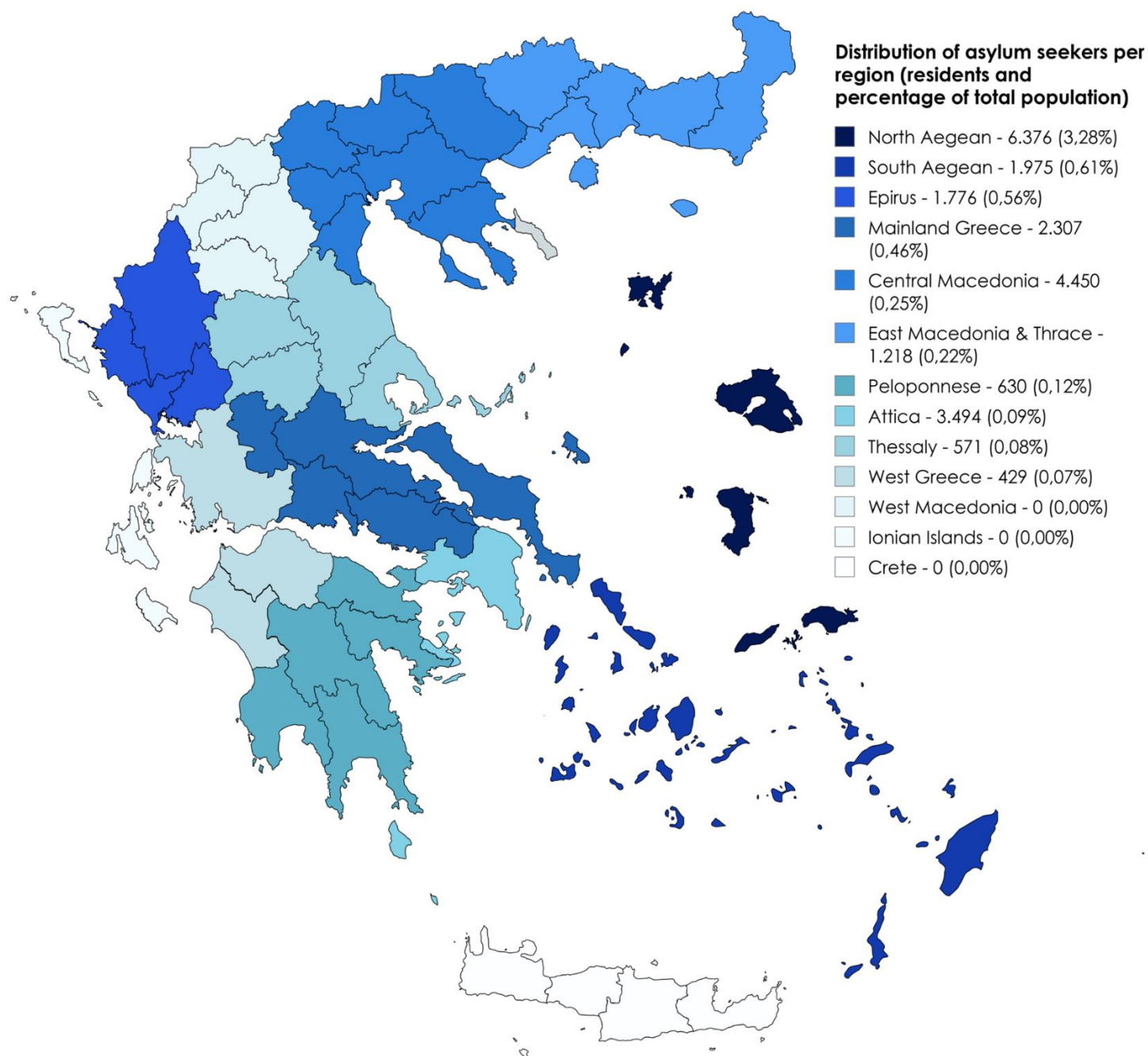


Chart 5. Distribution of Asylum Seekers per Region and Accommodation scheme – See Appendix Table 4 & 5

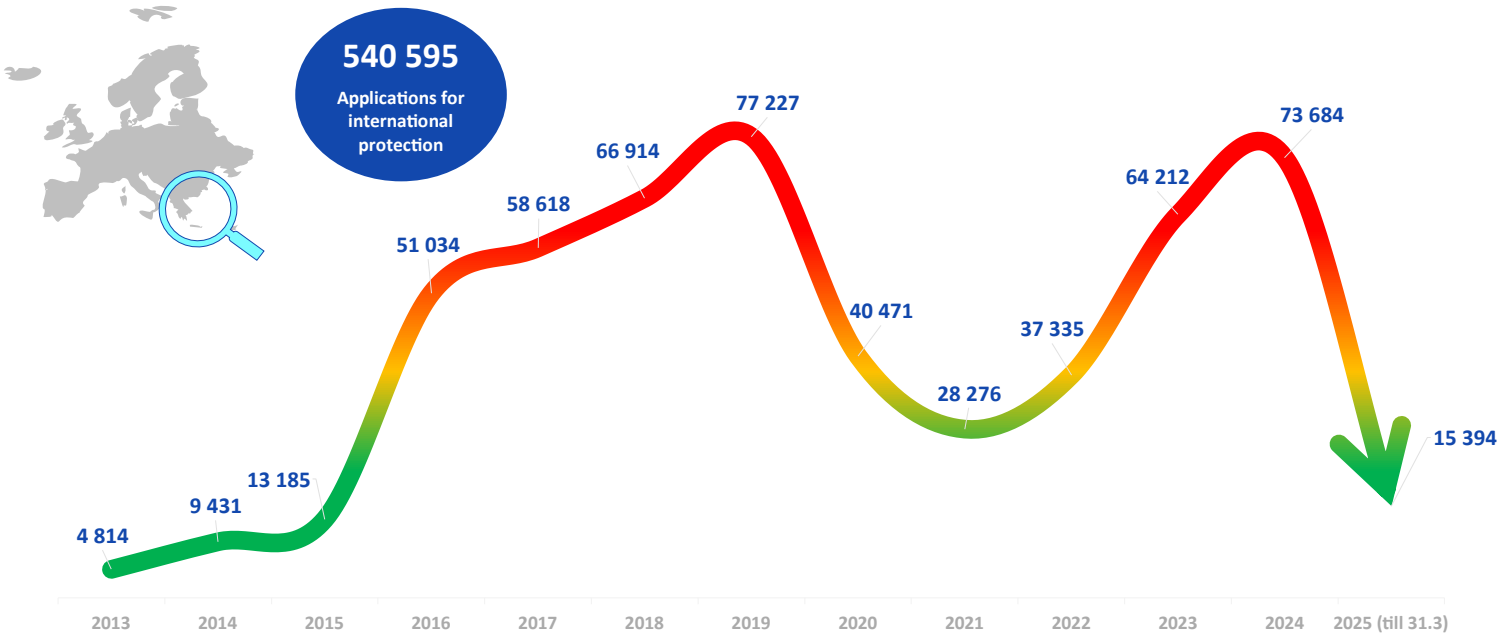


Chart 6. Applications for International Protection per year. For 2025 applications are calculated till the month of reference (March) - See Appendix Table 7a

5b. Applications for International Protection per Regional Office or Asylum Unit and per Region

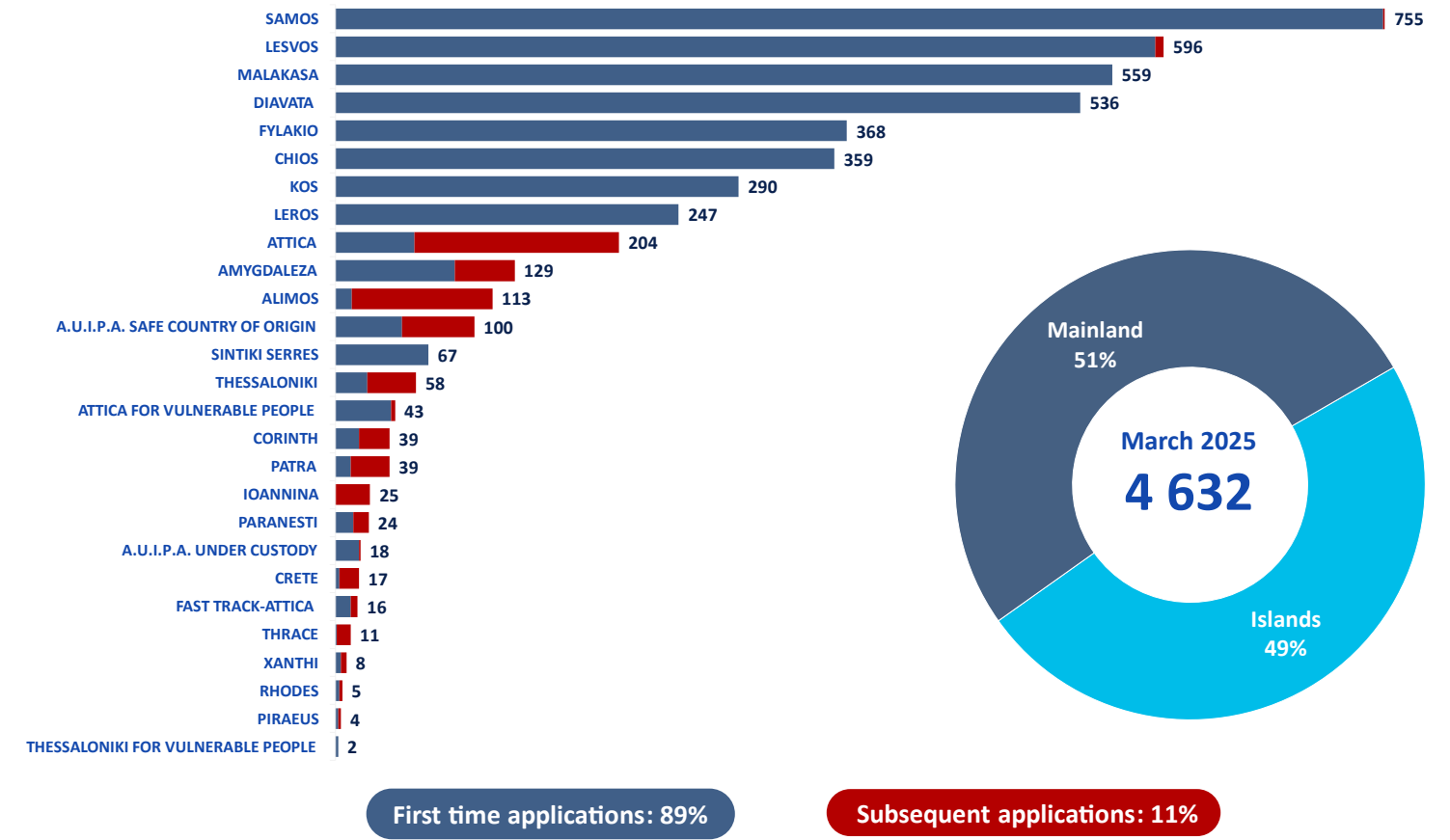

5c. Applications for International Protection per month with distinction between first time and subsequent

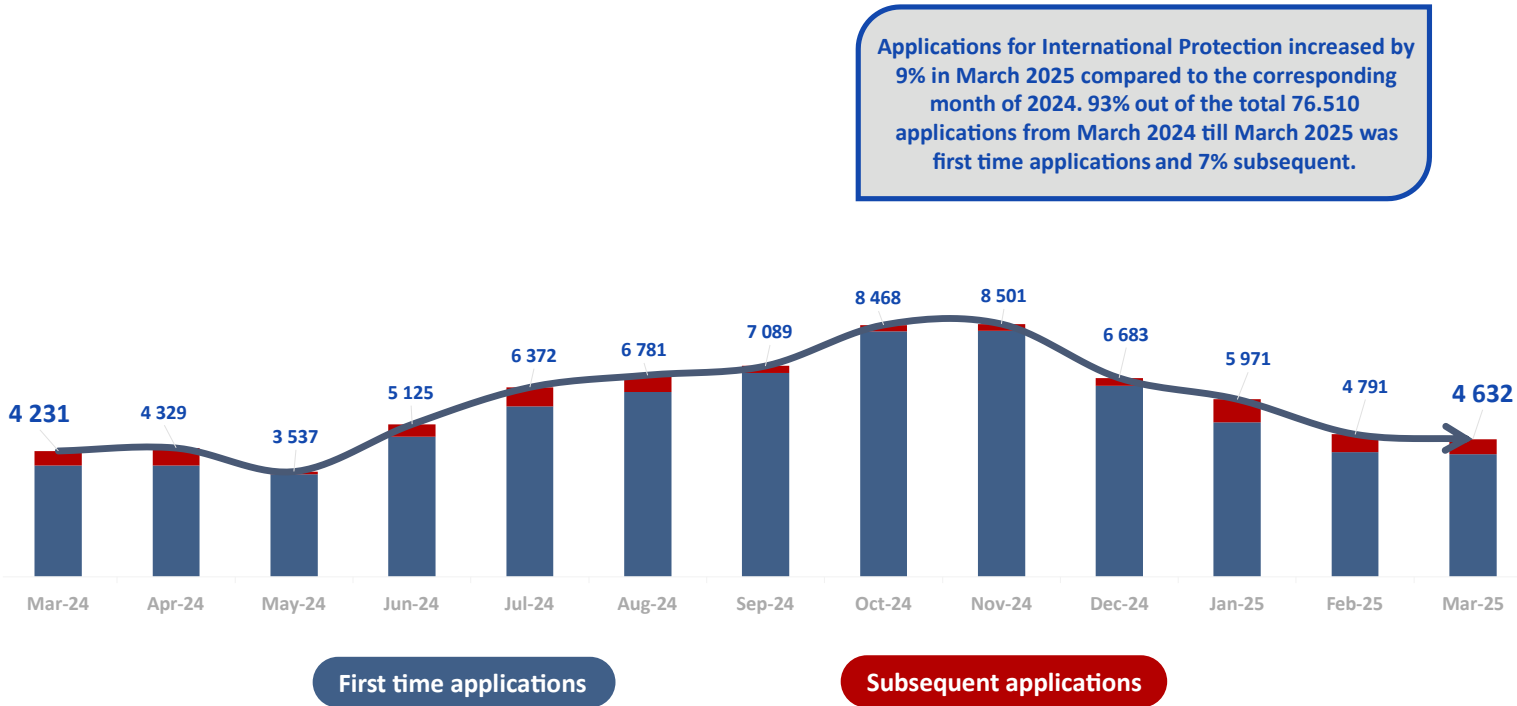


Chart 8. Applications for International Protection per month with distinction between first time and subsequent (March 2024 - March 2025) - See Appendix Table 7c

5d. Applications for International Protection per nationality, gender and age group

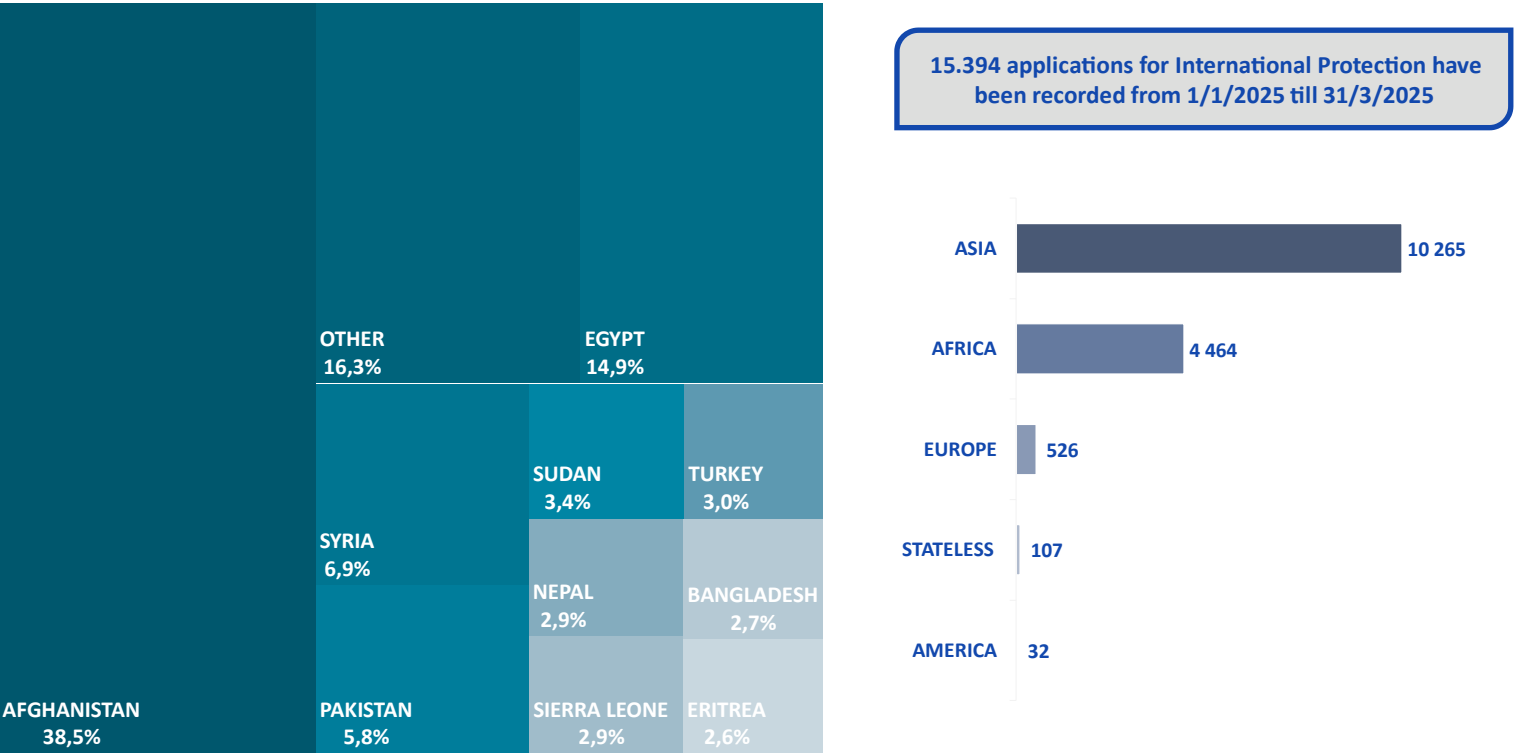


Chart 9. Applications for International Protection 3-months 2025 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 7d

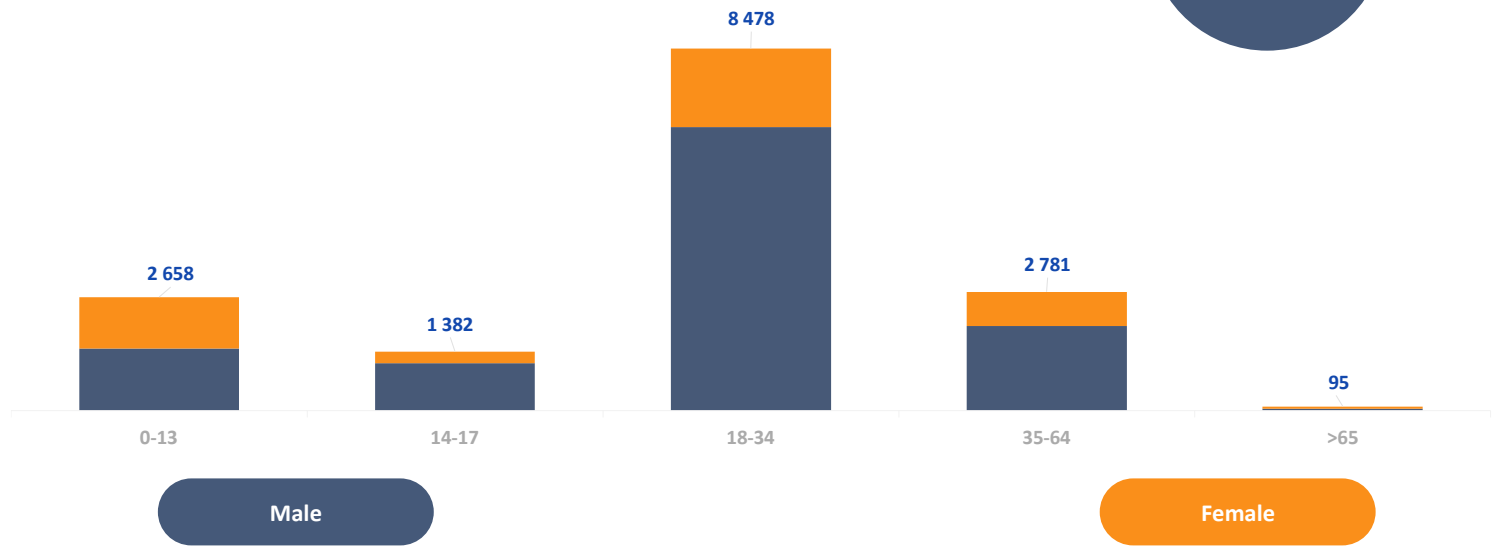
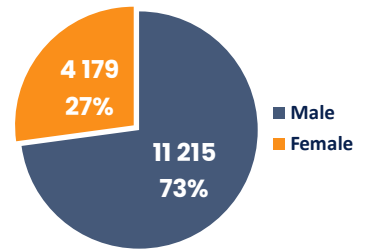


Chart 10. Applications for International Protection 3-months 2025 per gender and age group - See Appendix Table 7e

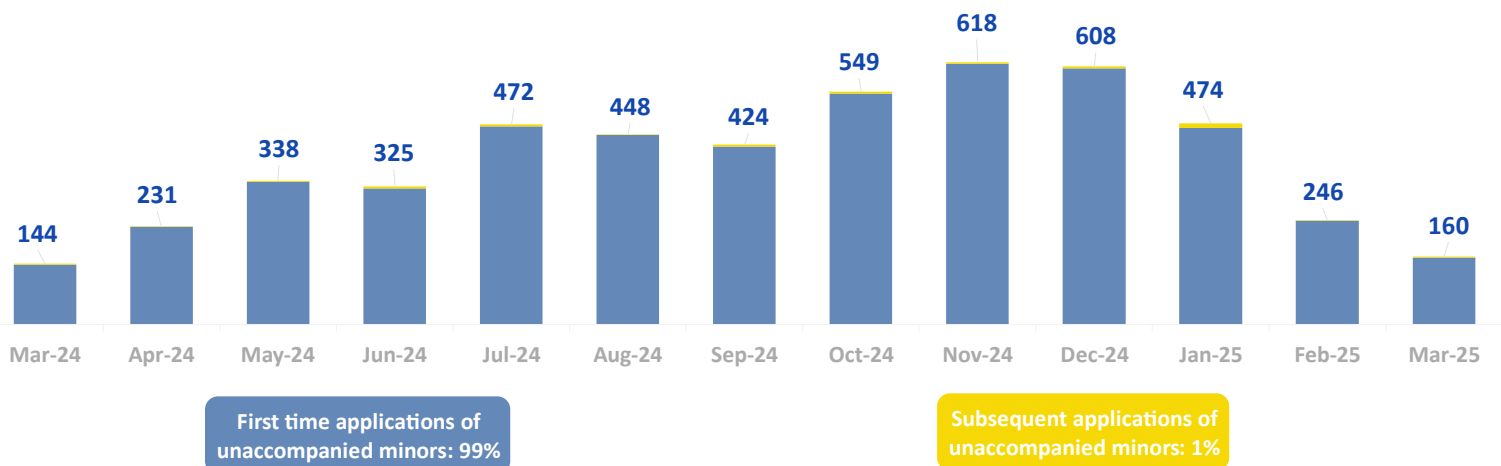
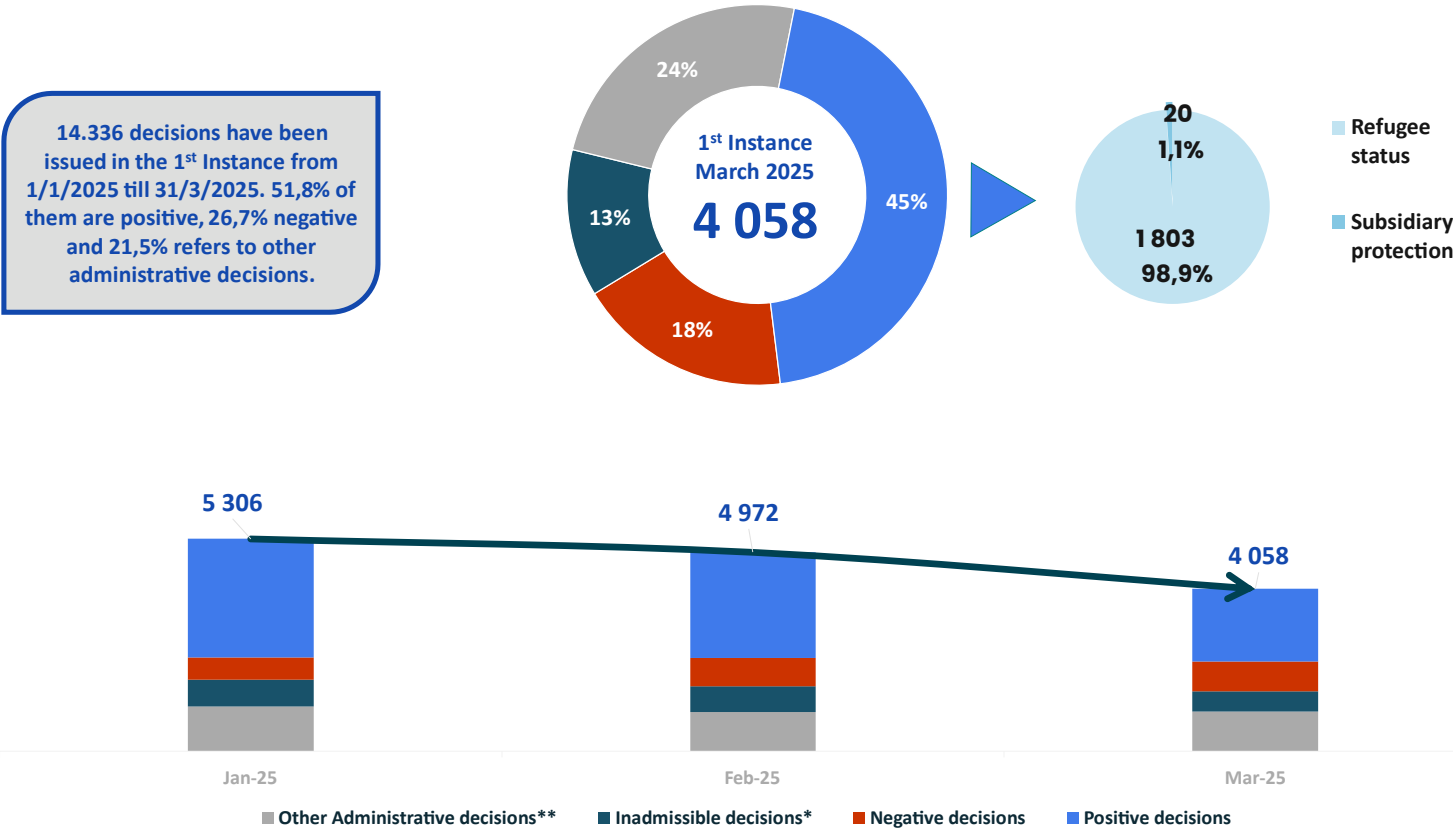

6a. Type of Decisions – 1st Instance

14.336 decisions have been issued in the 1st Instance from 1/1/2025 till 31/3/2025. 51,8% of them are positive, 26,7% negative and 21,5% refers to other administrative decisions.

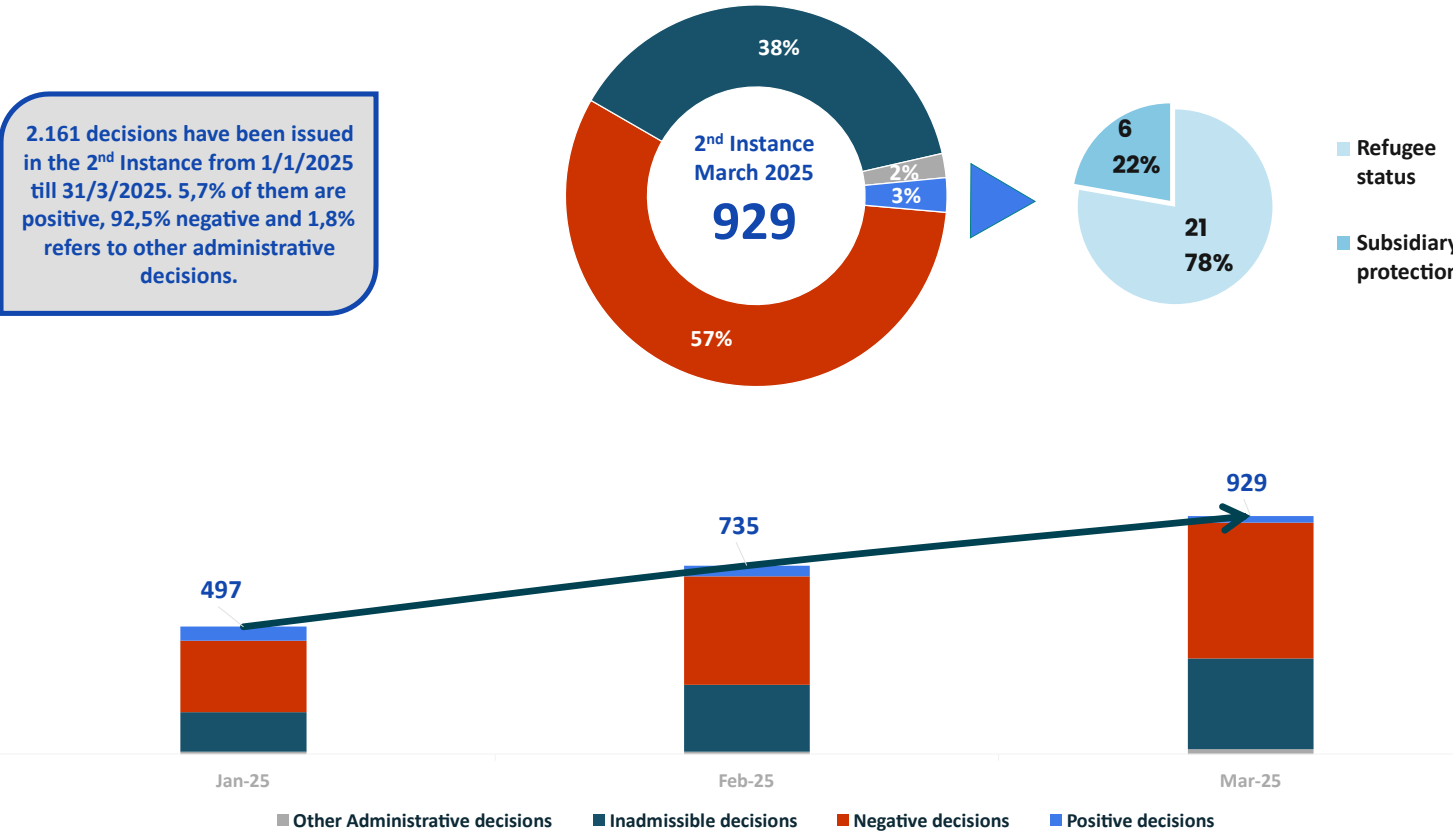


Chart 13. 2nd Instance Decisions per month and type for 2025 and for the month of reference (March 2025). - See Appendix Table 8b

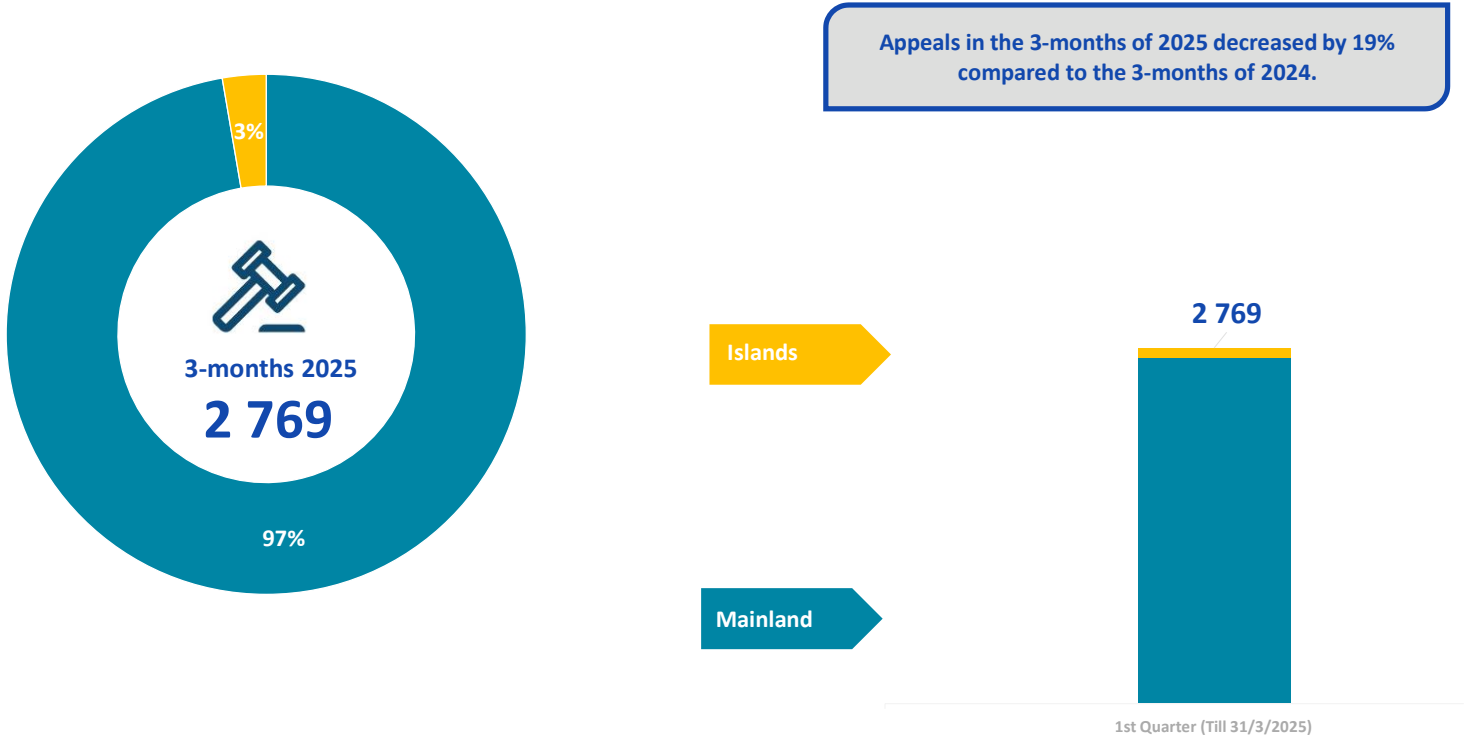


Chart 14. Appeals that have been lodged the 3-months of 2025 per location and quarter – See Appendix Table 9a

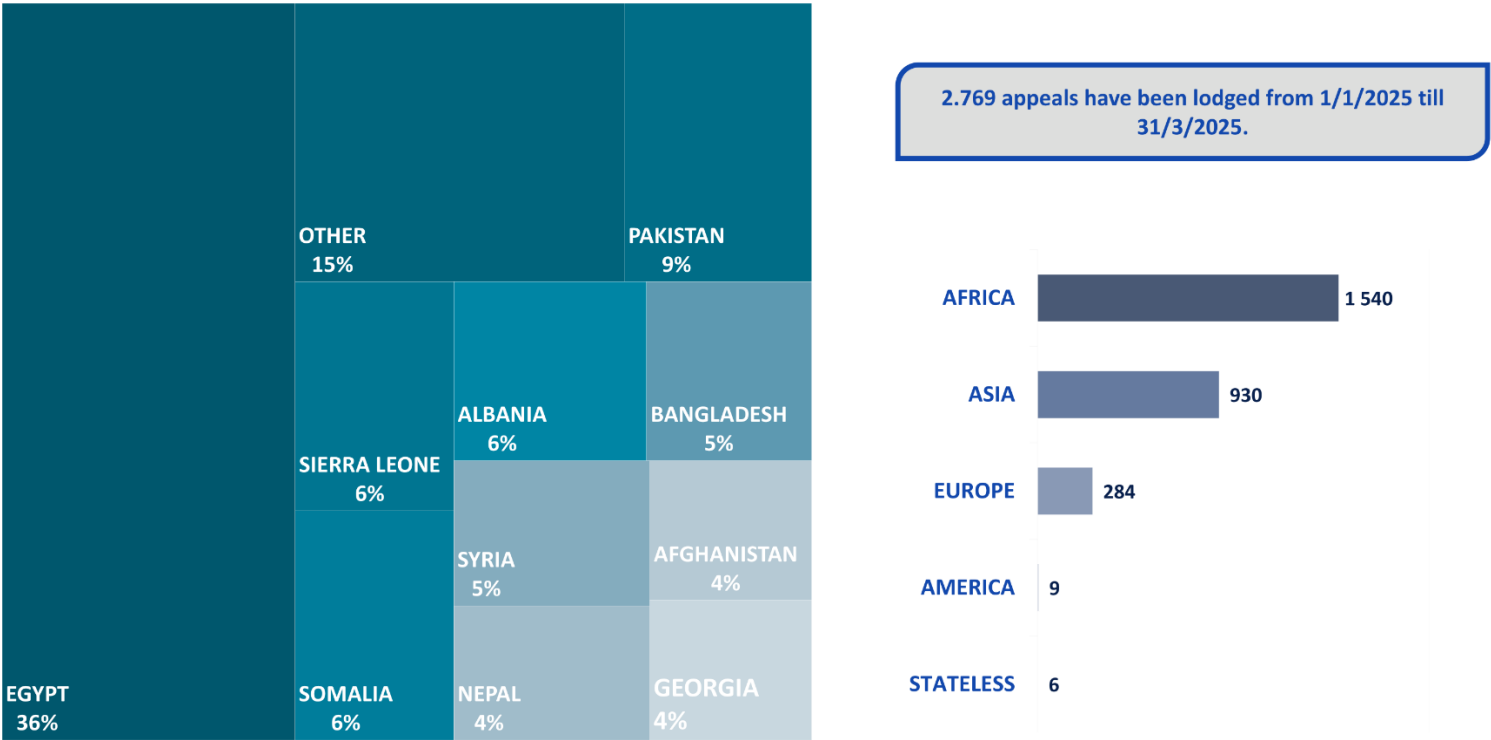

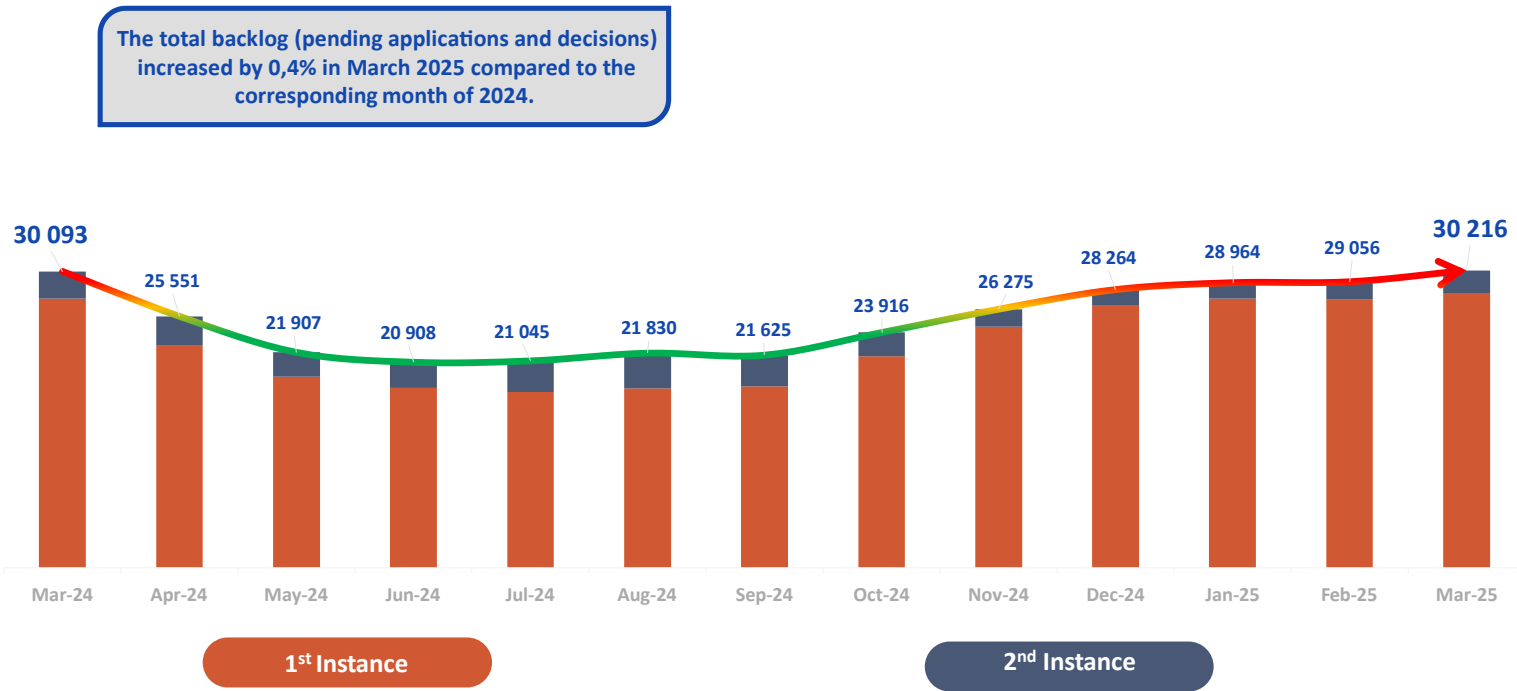

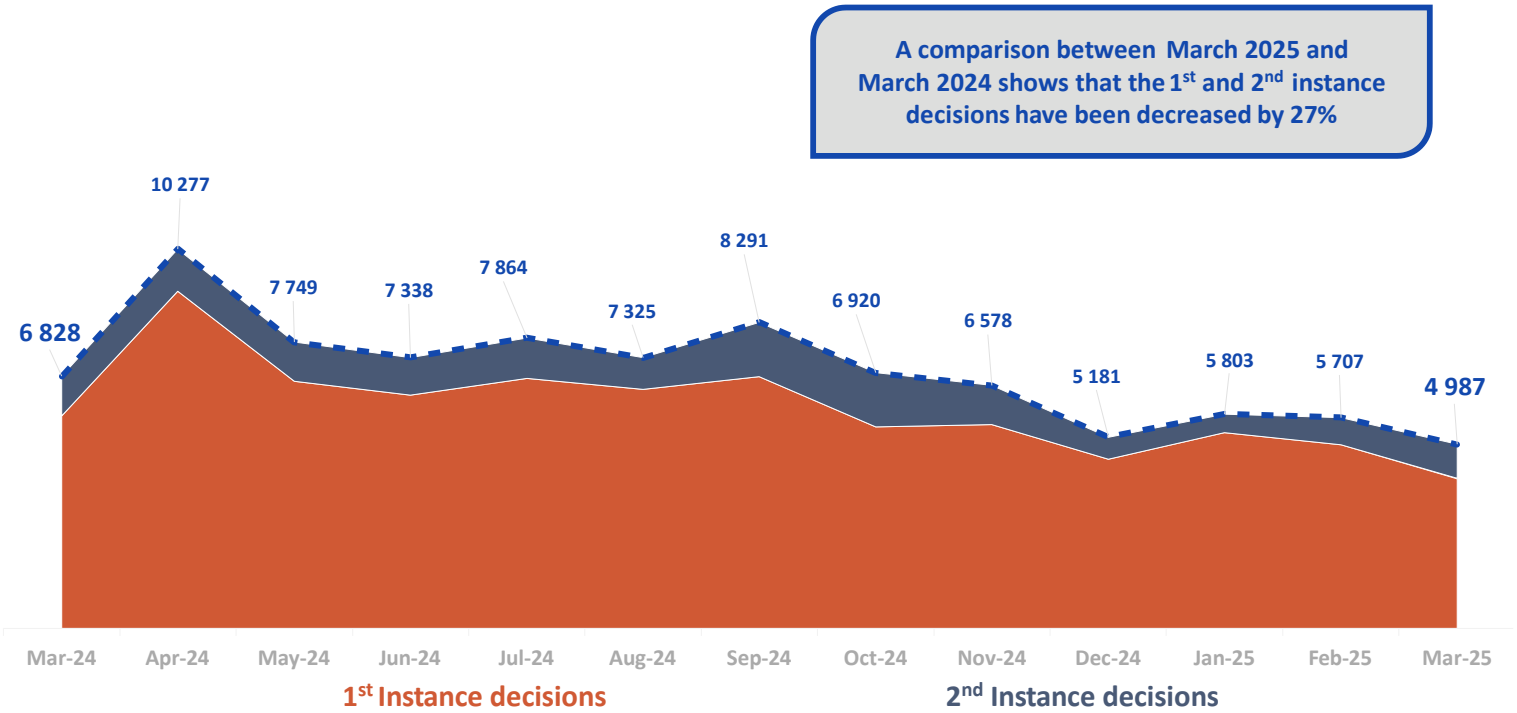


Chart 17. Aggregate Decisions issued in 1st and 2nd Instance per month - See Appendix Table 10a

- The average time for a 2nd Instance decision to be issued is 89 days since the date of appeal lodging, while it is 50 days from the date of appeal discussion.
- The number of appellants who applied and benefited from free legal aid is 1.937 in the 1st Quarter of 2025.
- The total of pending decisions of Appeals Authority (2.261 pending) consists of cases that have been discussed till March 2025 (1.320 pending) or are scheduled to be discussed till August 2025 (941 pending).

A comparison between March 2025 and March 2024 shows that the pending decisions in 1st and 2nd instance regarding notification status have been decreased by 41%

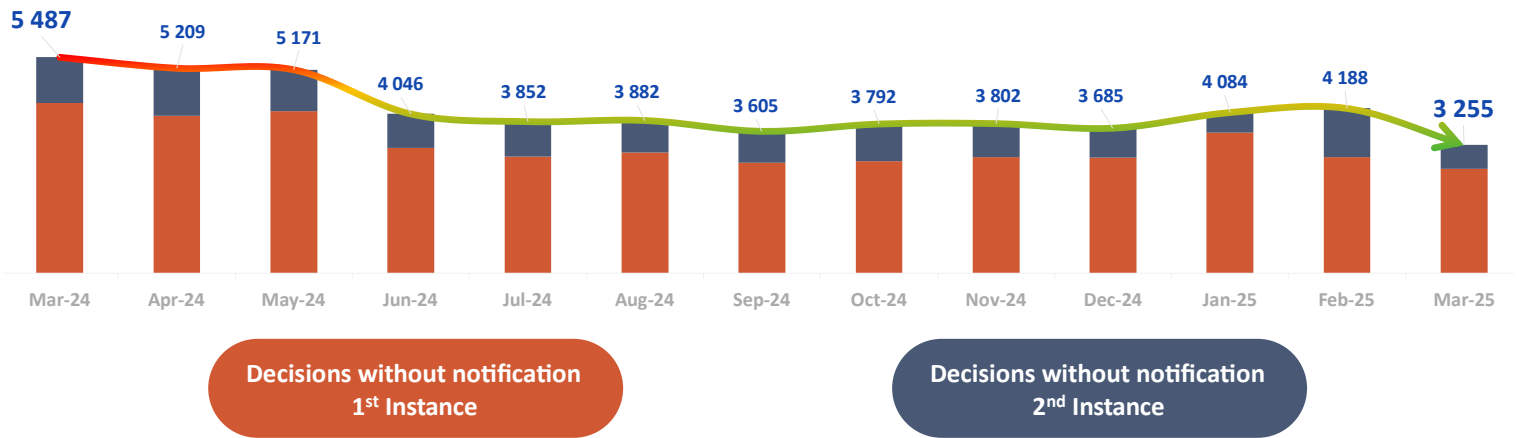


Chart 18. Aggregate pending decisions in 1st and 2nd instance regarding notification status per month - See Appendix Table 10c

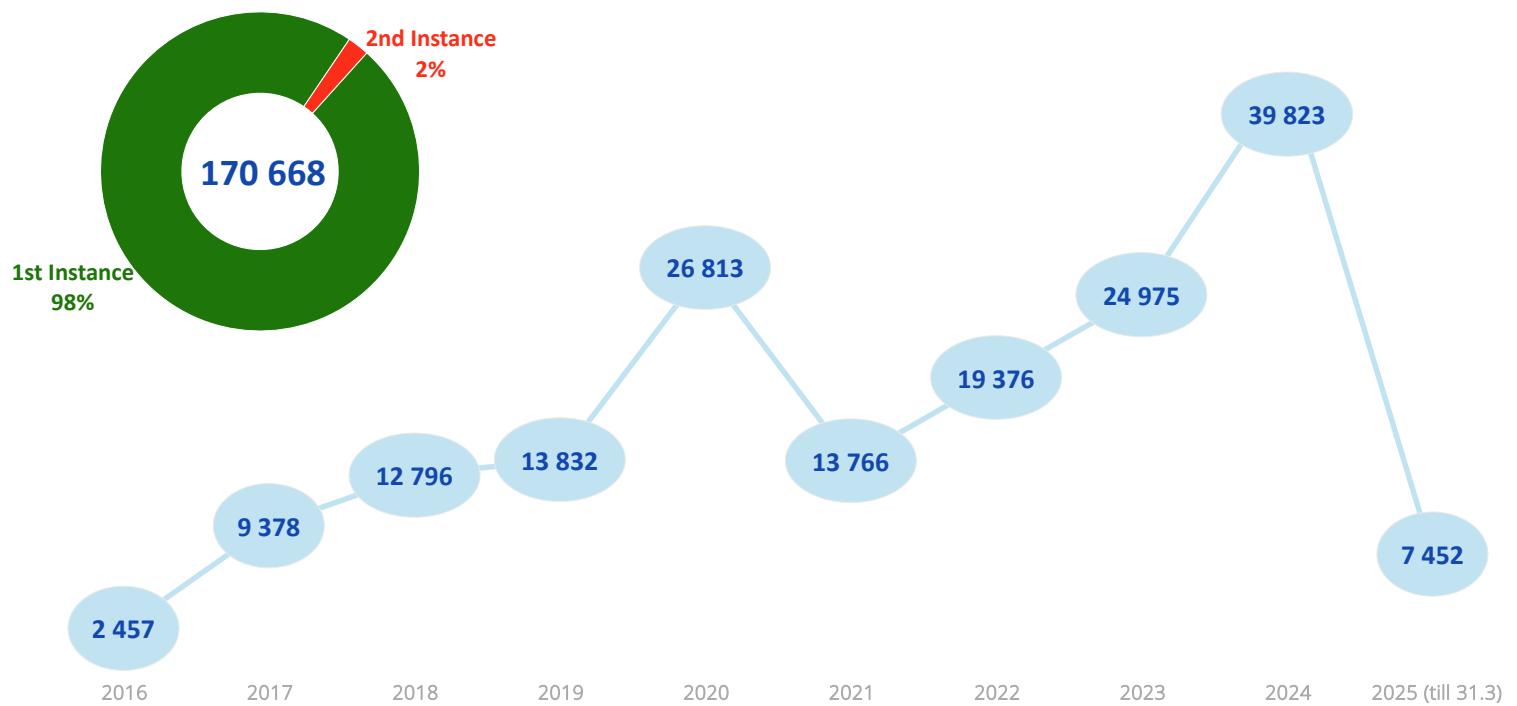

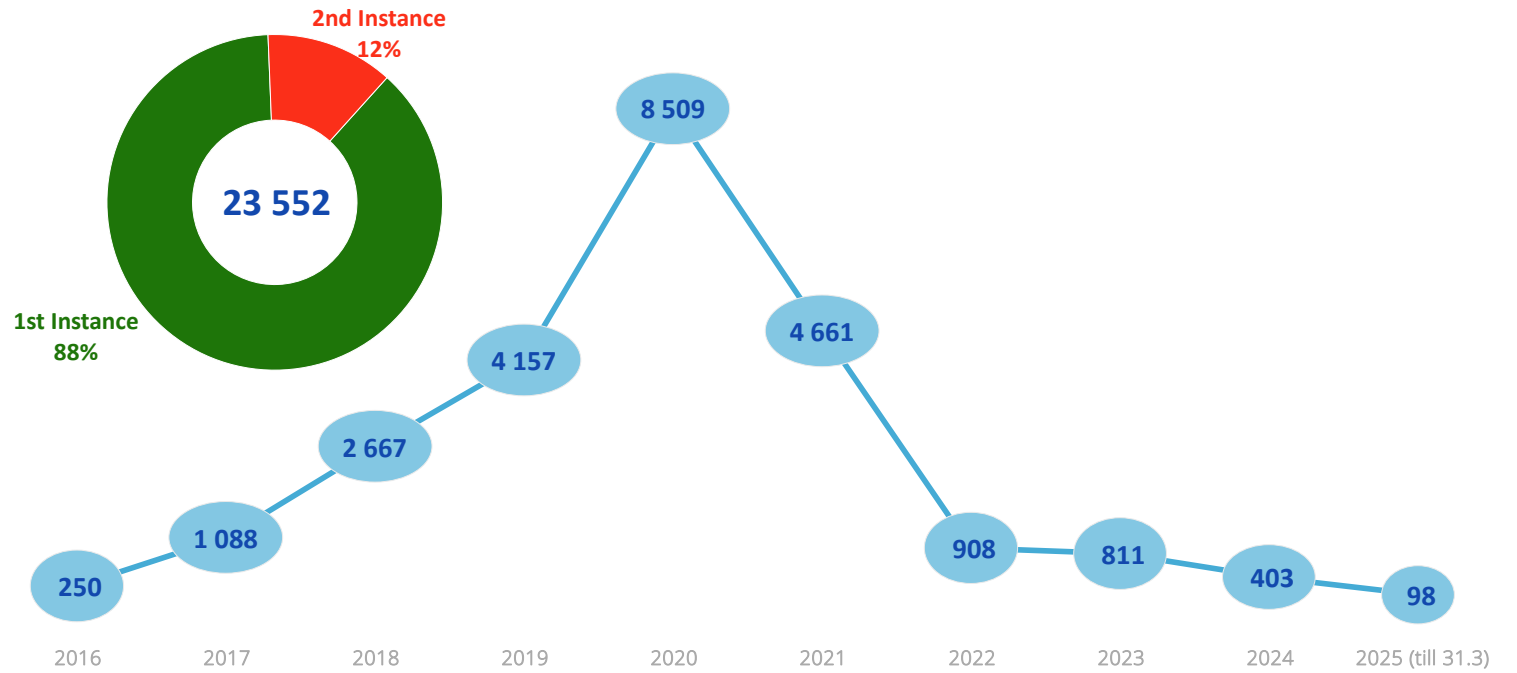

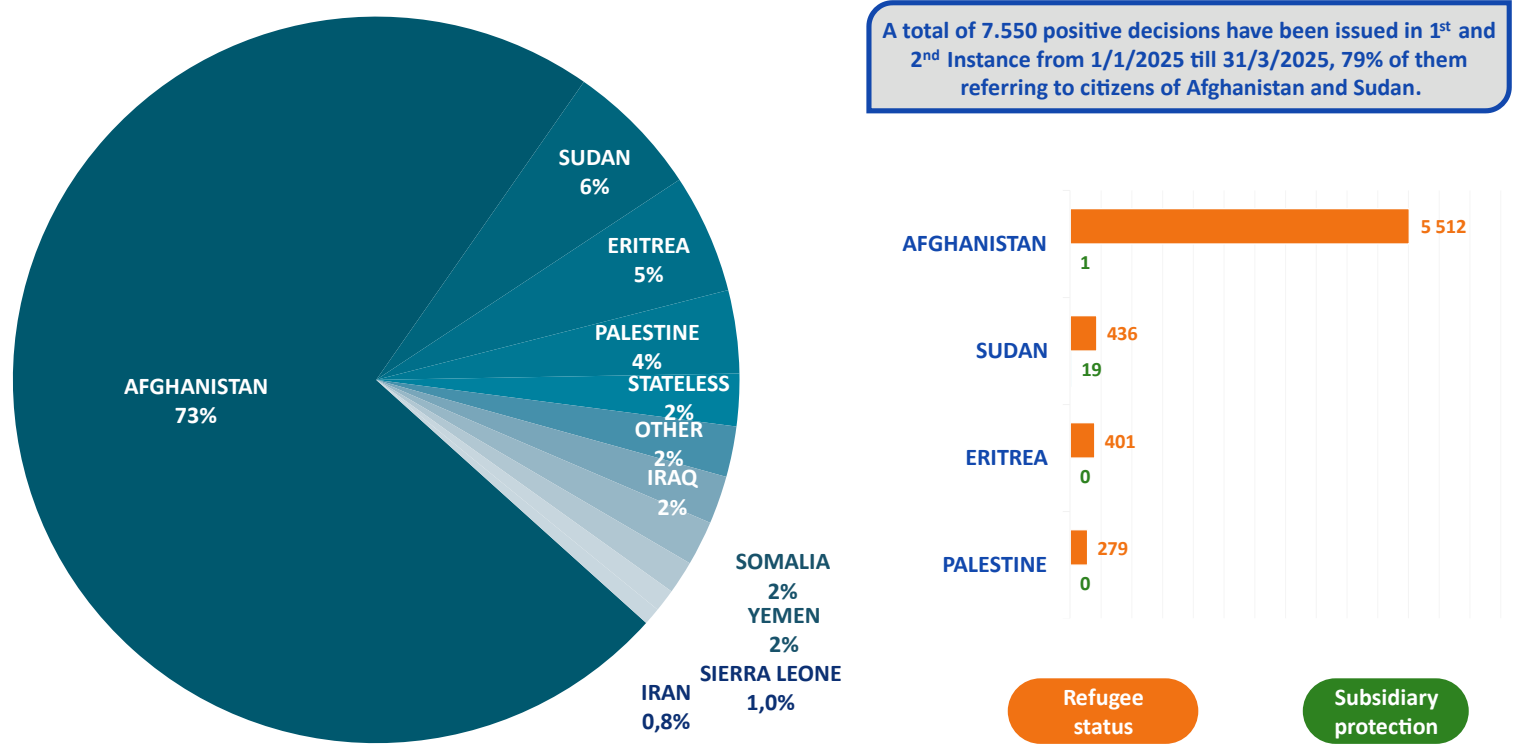

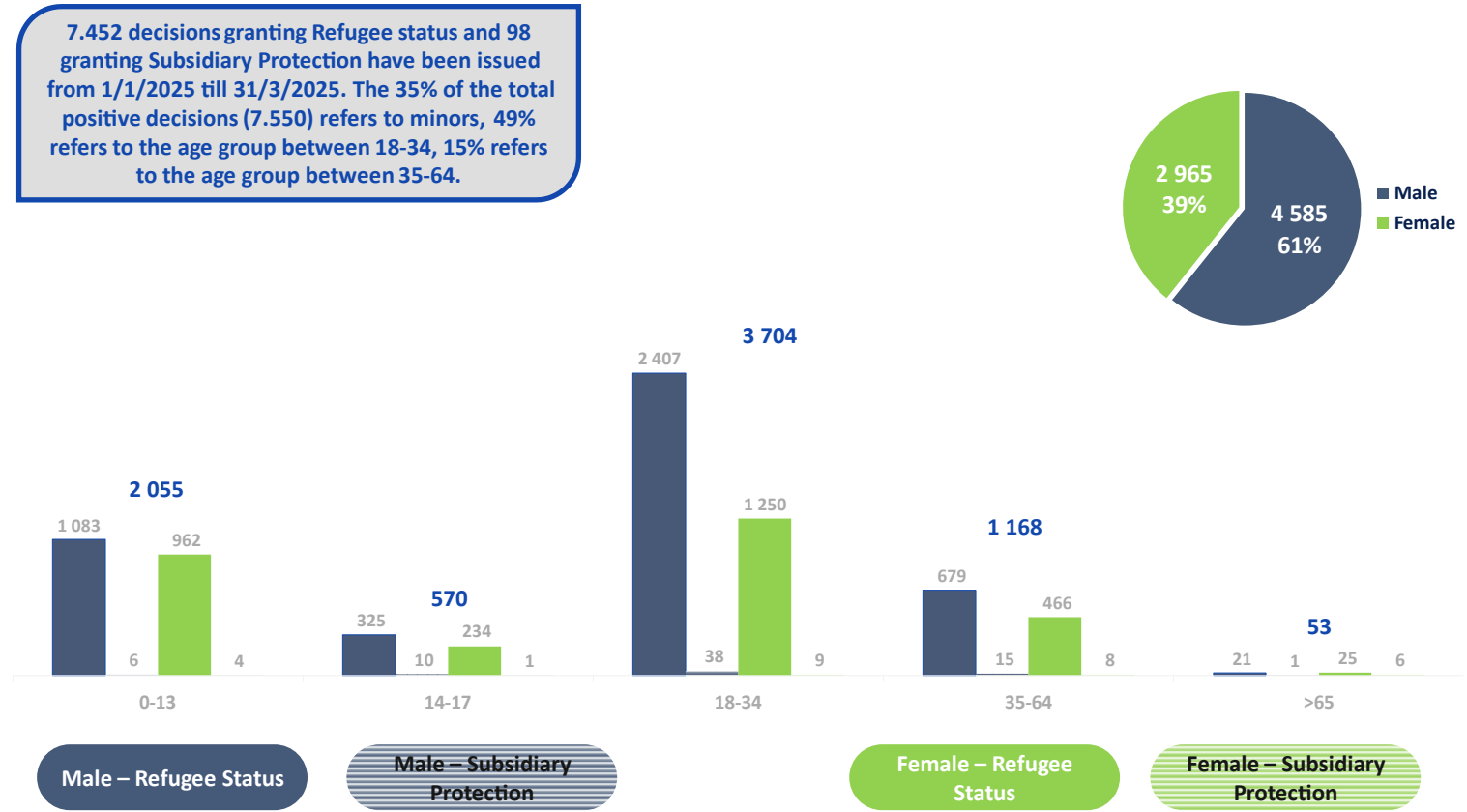

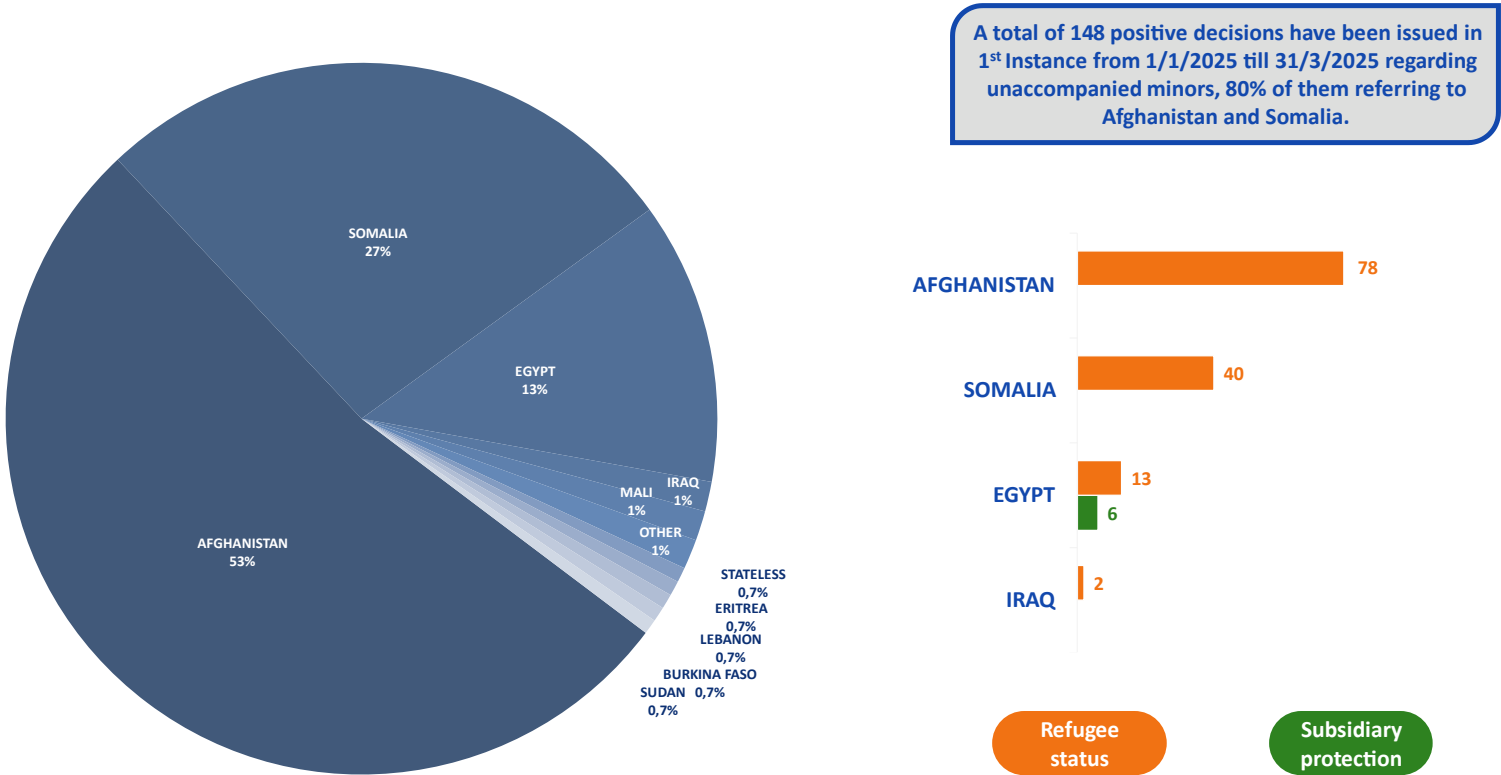

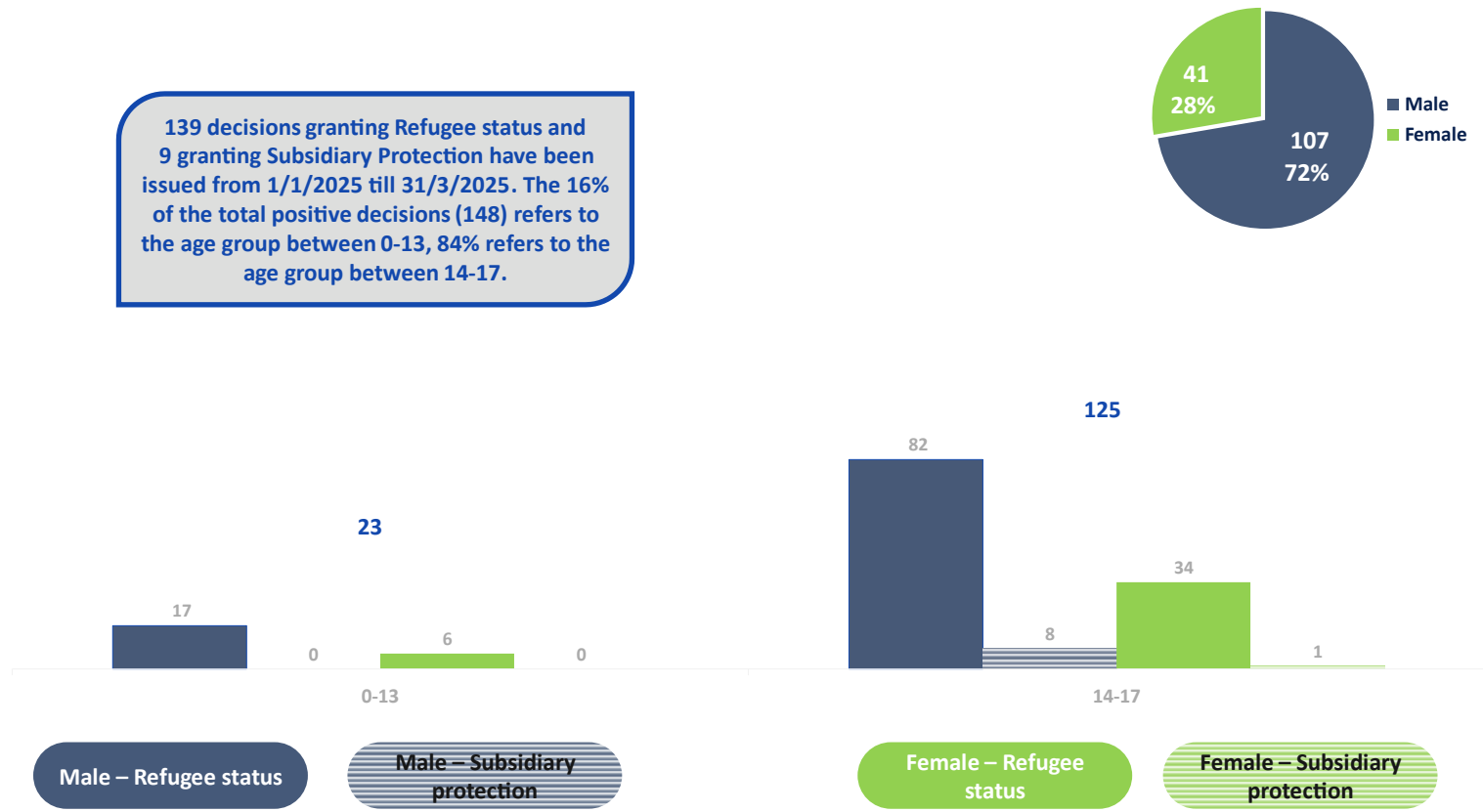

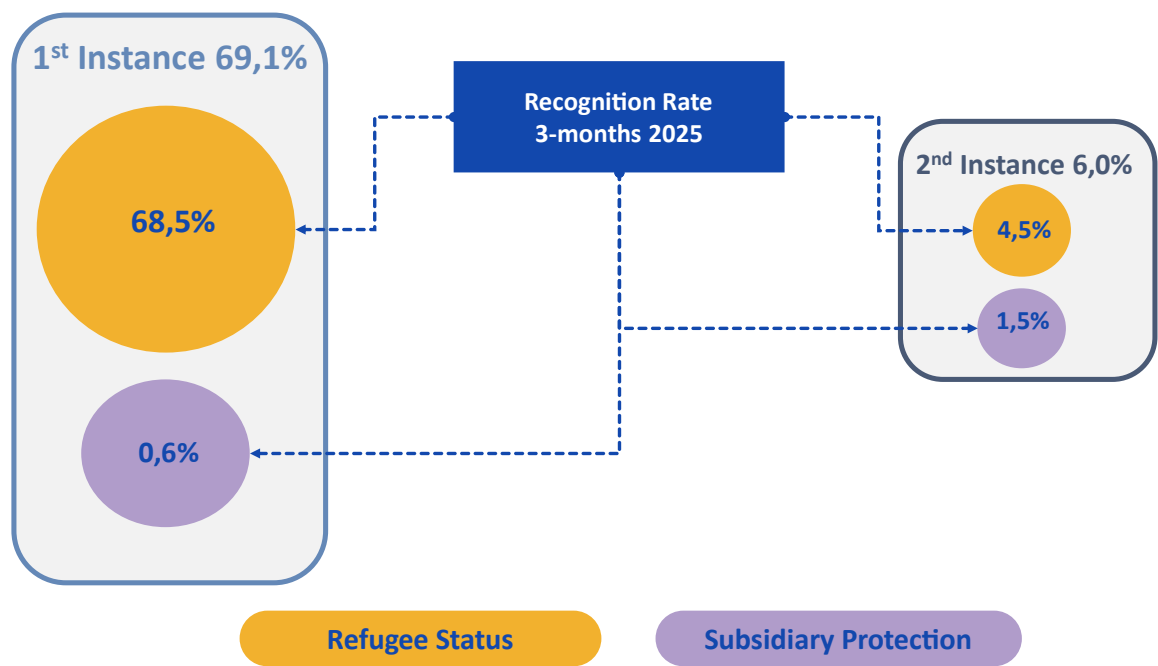


Chart 25. Recognition Rate in 1st & 2nd Instance. See Appendix Table 11g

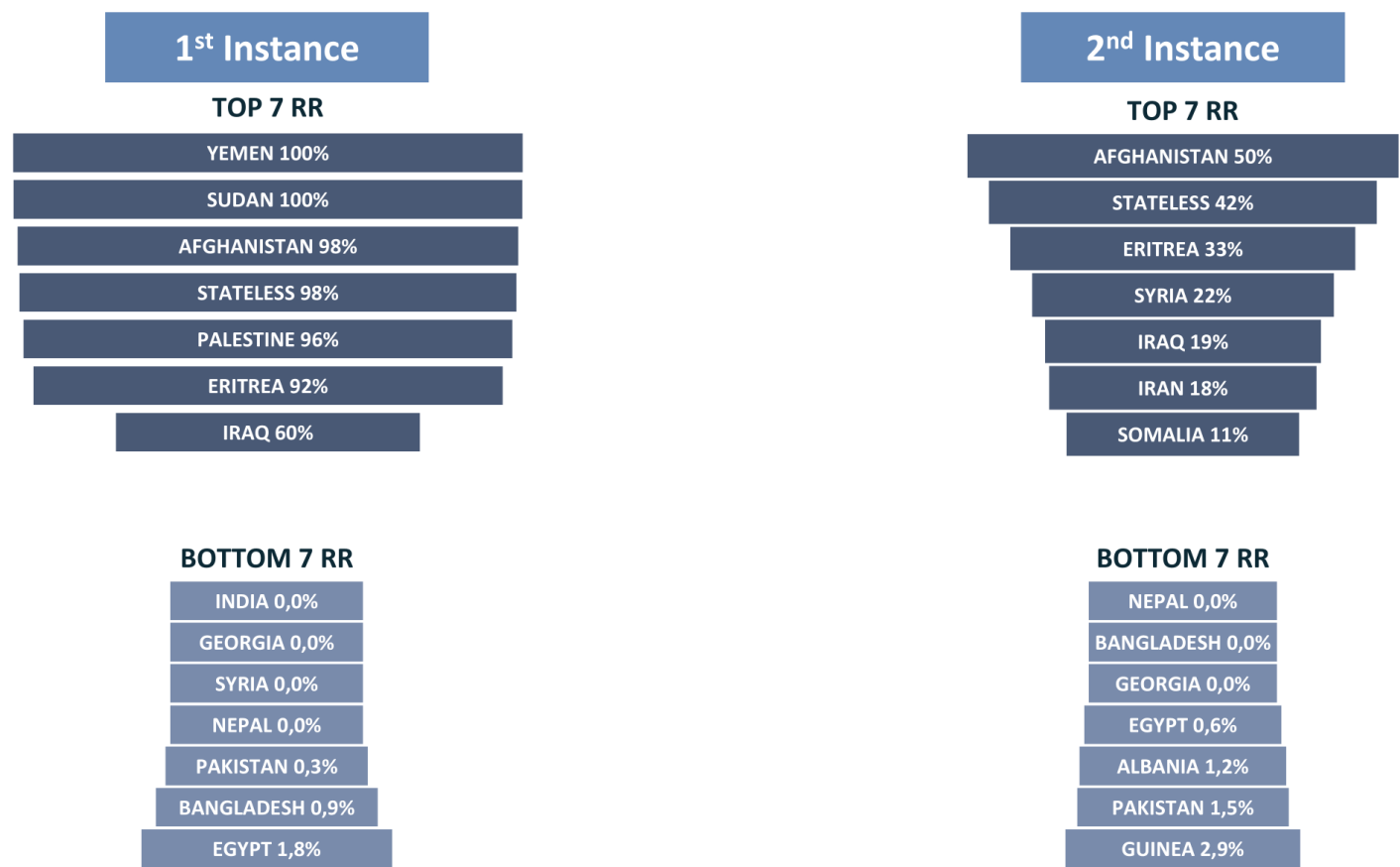

10. Applications for annulment of 2nd Instance Decisions before the Administrative Court

The 23,3% of the total applications for annulment per year of lodging (6.456) are pending while for the rest of them (76,7%), a decision has been issued. 4,6% of the decisions had a positive outcome and 95,4% were rejected.

From the total of 4.950 decisions regarding applications for annulment (per year of decision) 60% have been issued in 2022, 2023, 2024 and 2025.

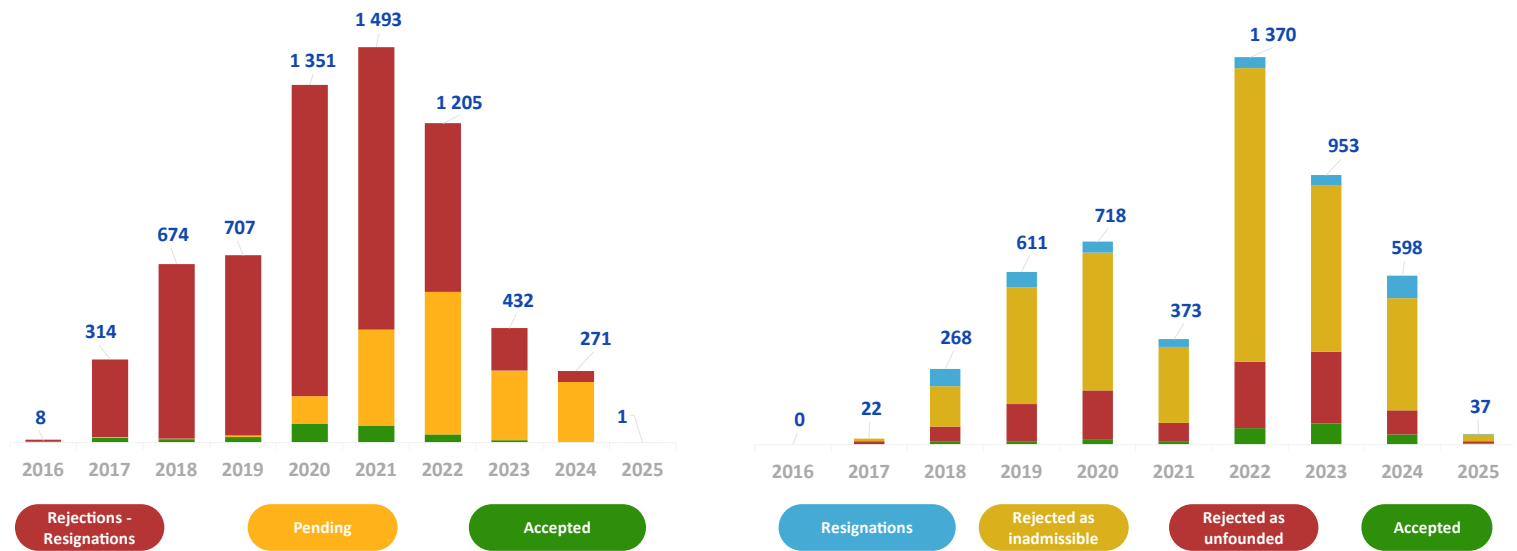

11. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 30/11/2024 47.753 people have registered in the program (*data regarding the enrollments are up to 31/8/2024), while 24.509 recognized refugees receive financial assistance for renting a house (*data regarding house renting are up to 31/10/2024). It is worth noting that in October 2024, 3 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/10/2024 till 31/10/2024). At the same time 10.659 beneficiaries of International Protection have been enrolled in the integration courses and 12.693 people are attending job counselling sessions.

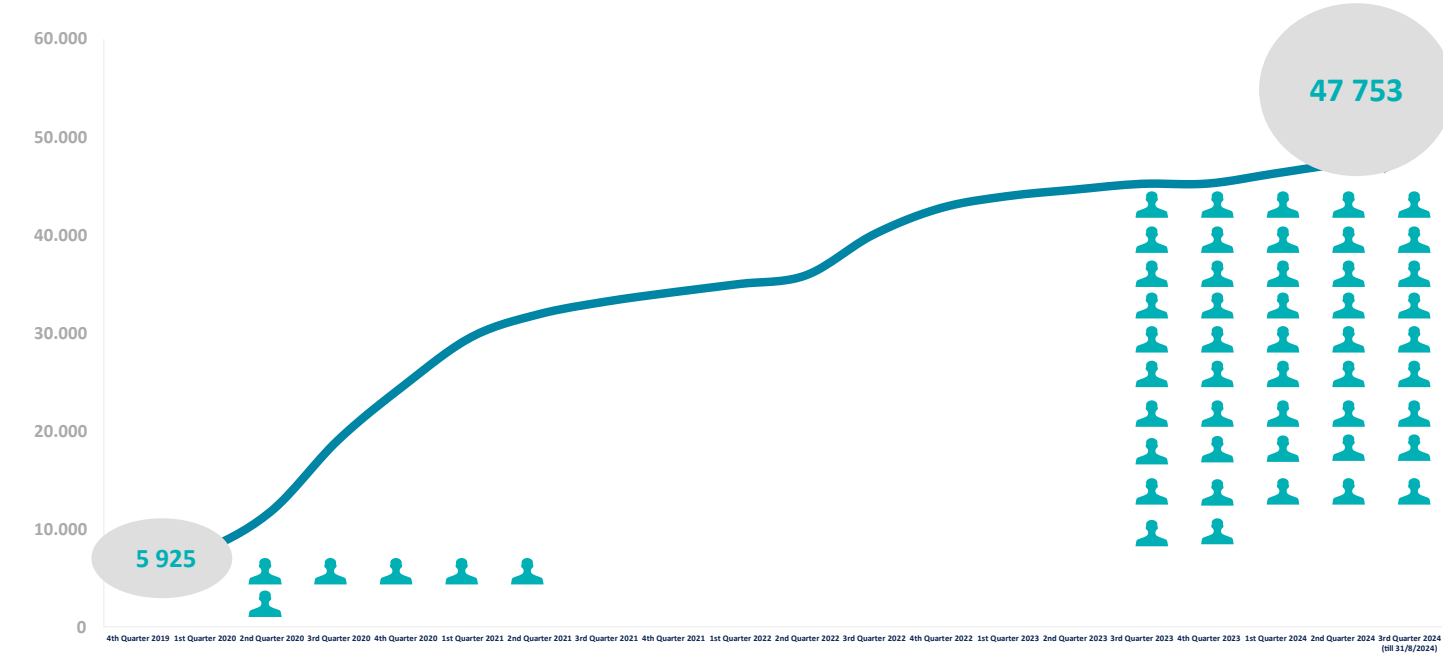


Chart 28. Helios Enrollments – See Appendix Table 13

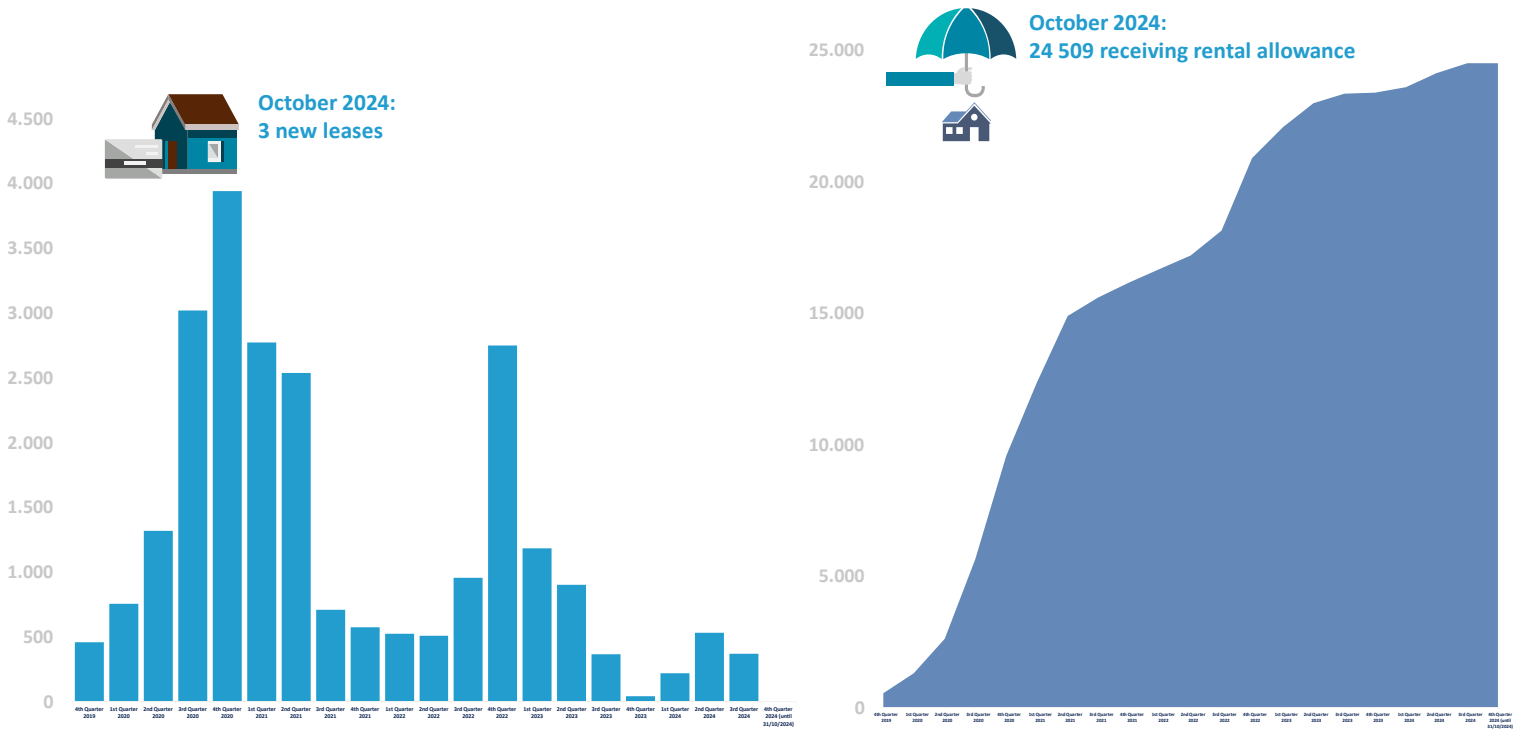


Chart 29. New leases (left), Receiving rental allowance (Right) - See Appendix Table 14 and 15

12. Returns - Departures

- In March 2025 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:
- 183 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
 - 26 voluntary departures through IOM.
 - 85 voluntary departures of immigrants from our country to their countries of origin.
 - 90 transfers to Member States of the European Union under the Dublin Regulation.
 - 17 people seeking International Protection were transferred to France (7) and Romania (10) in the context of voluntarily relocation program.
 - Returns under the EU - Turkey Joint Declaration have not been made since March 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
 - A total of 401 people left the country in March, while 2.245 arrived.

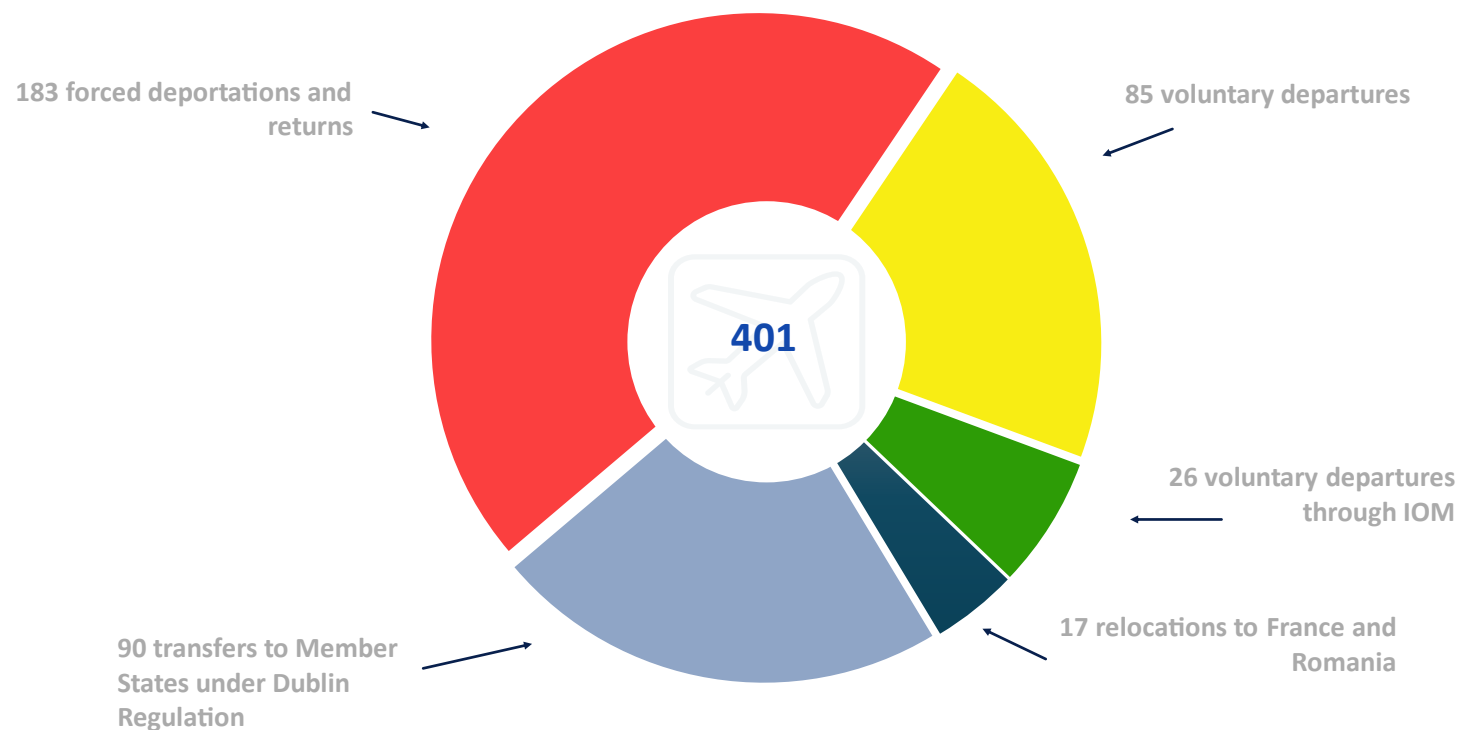


Chart 30. Returns-Departures – See Appendix Table 16.

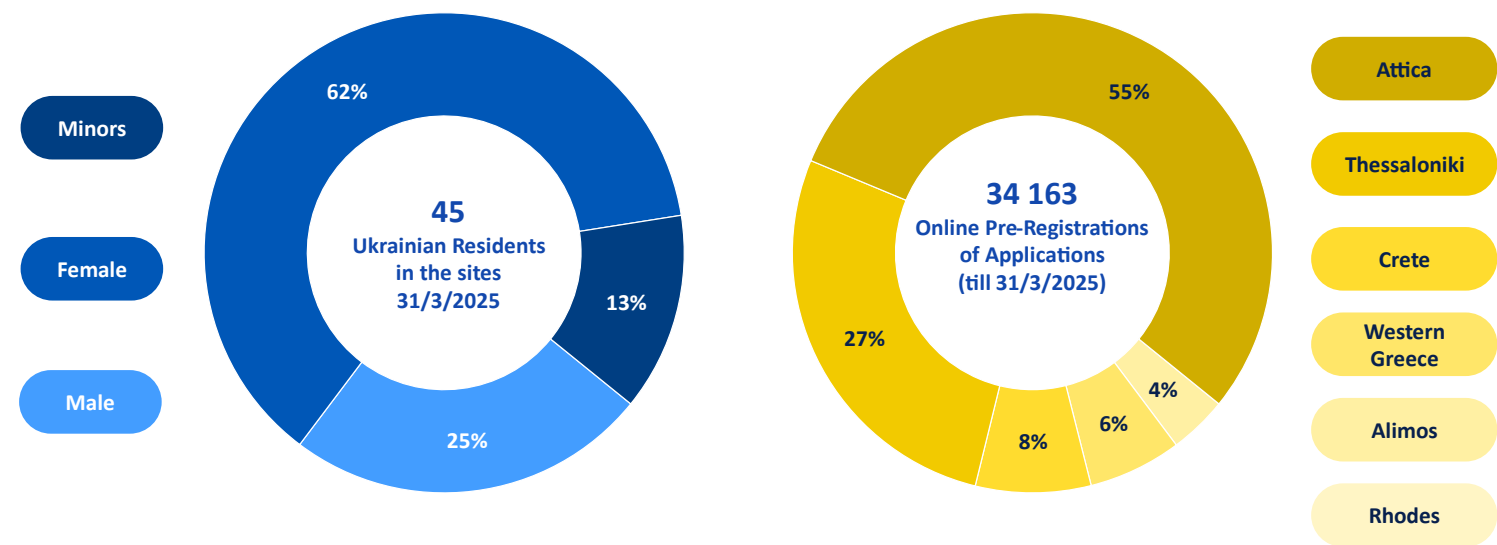


Chart 31. Total Ukrainian Residents & Online pre-registrations of applications (March 2025) - See Appendix Table 17 & 18

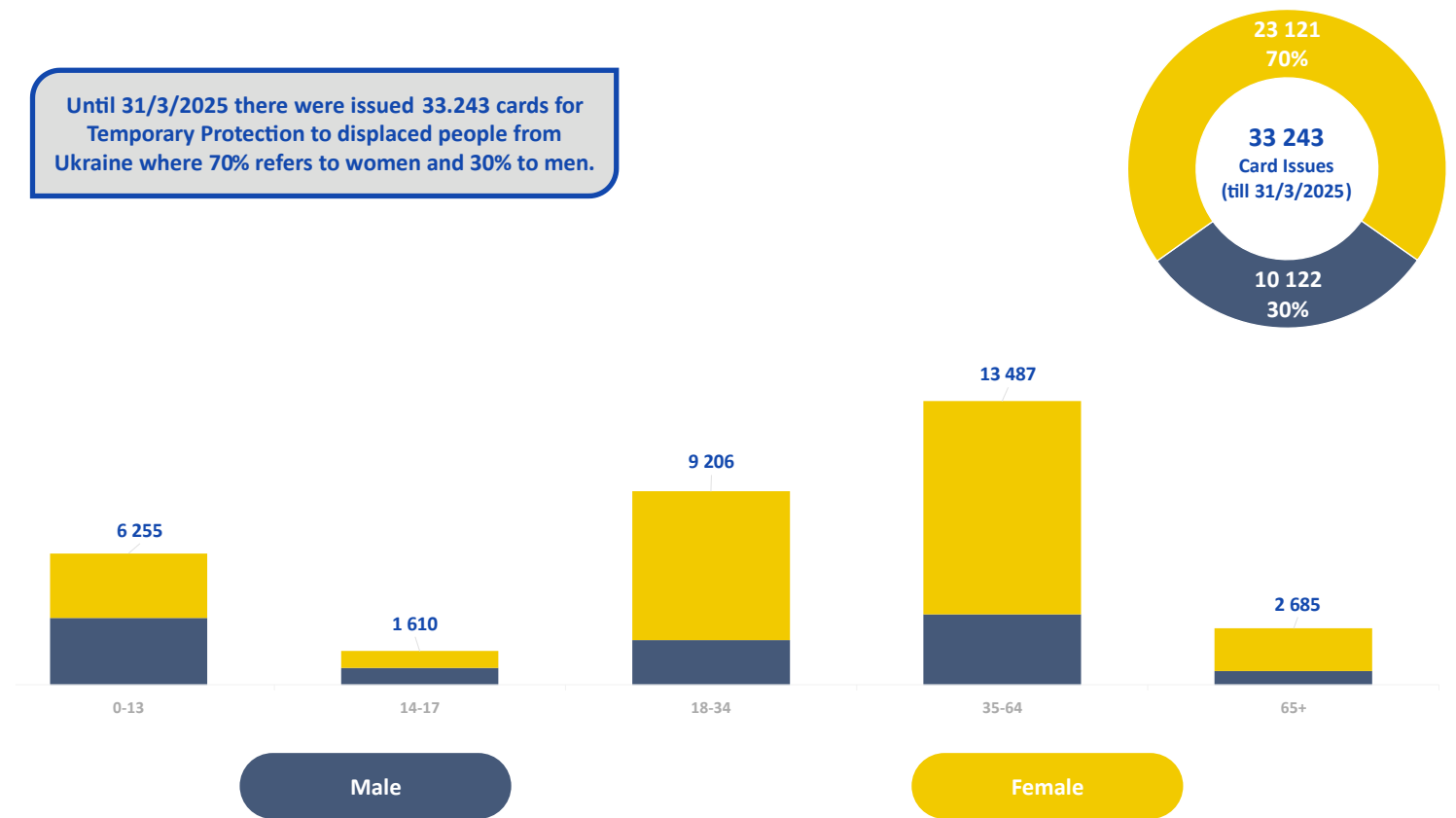


Chart 32. Total card issues to Ukrainians for Temporary Protection per age group and gender (March 2025) - See Appendix Table 19

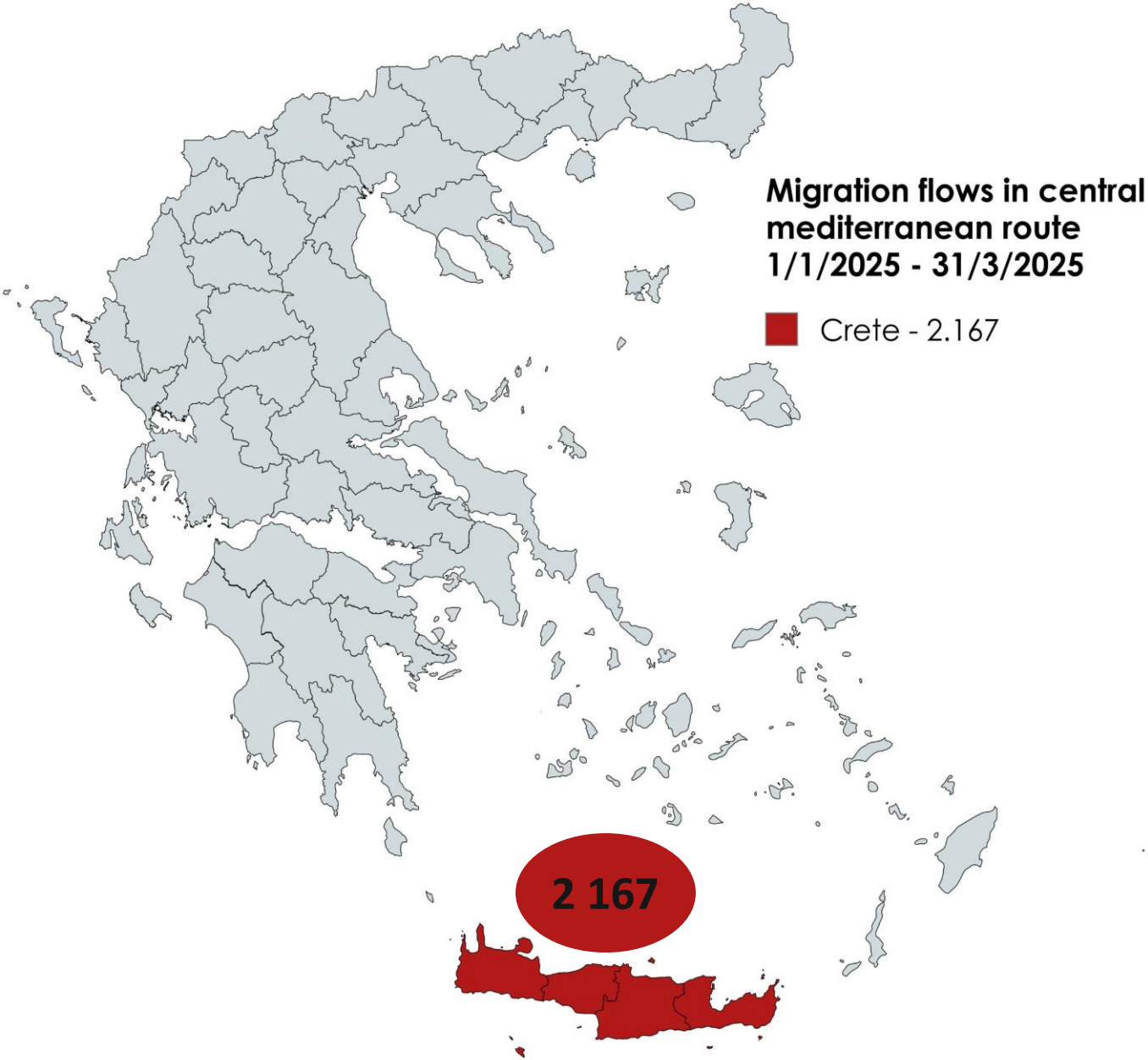


Chart 33. Migration flows in central mediterranean route (1/1/2025-31/3/2025) - See Appendix Table 20
